10 (ten) Research Fellowships (BI) for MSc Student

10 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution “LASIGE”, “UIDP/00408/2020”, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme Programmatic Funding 2020-23, under the following conditions:

1. **Scientific Area:** Computer Science and Engineering.
2. **Requirements for admission:** BSc completed. Submit the application form filled in. Form available at: <https://cloud.lasige.di.fc.ul.pt/index.php/s/RkrmckWcTascpEH>
3. **Additional optional skills and qualifications:** Enrolment in the second year of a MSc degree in the Department of Informatics of the Faculty of Sciences of the University of Lisbon.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in a MSc degree in the academic year 2023/2024.
5. **Work plan:** Development of a research project framed in one of the lines of research at LASIGE (<https://www.lasige.pt/>), under the supervision of a PhD member of the Unit.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](#)).
7. **Place of work:** The work will be developed at the LASIGE, Department of Informatics of the Faculty of Sciences of the University of Lisbon under the scientific supervision of Professor a PhD member of LASIGE.
8. **Fellowship duration:** This position is initially opened for 3 months due to start in October 2023. The fellowship contract may be potentially renewed for 3 months.
9. **Monthly allowance:** The fellowship amounts to € 930,98, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by
- CV: 20%
 - BSc's grades (on the European Scale of Comparability of Ratings*): 35%
 - Research experience (subject to confirmation by letter(s) of recommendation signed by the supervisor(s) of the previous research project(s)): 15%;
 - Analysis of the research work plan and application form filled in: 30%;
- * Holders of pre-Bologna degrees are exempt from presenting the BSc Certificate with European Scale of Comparability of Classifications.
- Applicants whose application is scored with a final classification of less than 60 points are not eligible for granting a fellowship.
11. **Selection Committee:** Chair of the jury: Alysso Bessani;

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.
13. **Deadlines:** This call for applications is open from 18/09/2023 to 29/09/2023 .
14. **Application:** Applications should be sent via e-mail to lasige-candidaturas@listas.di.ciencias.ulisboa.pt, indicating - otherwise they will not be considered eligible - at subject: 816.4 – PEI 10 BI EM LASIGE, by attaching the following documents:
- a. Curriculum vitae, with the mandatory inclusion of the degrees obtained and/or to be attended, curricular units, respective grades and ECTS;
 - b. Certificate of completion of previous degree (with European Scale of Comparability of Classifications*) ^{Note 1, 2;}

 - d. Letter(s) of recommendation signed by the supervisor(s) of the previous research project(s) (if research experience is mentioned at the application form).
 - e. Research work plan.
 - f. Other supporting documents considered relevant.

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.
- The personal data will be kept for the period necessary for the execution of the purposes for which they are intended, being ensured the processing and protection in an appropriate and diligent way, the confidentiality and integrity of these data, through appropriate technical and organizational measures.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates' evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date.

Note 1: The documents that prove the entitlement of the academic qualifications and diplomas can be dismissed during the application period and replaced by a declaration on their honour from the applicant ([Minuta PT](#), [Minute EN](#)). Their delivery is mandatory for the fellowship contractualization.

Note 2: Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
