

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### 1 (one) Research Fellowship under Special Regime (BI-RE) for Master Student

1 Research Fellowship(s) under Special Regime (BI-RE) is (are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the Project “DYNAMICTRIO: Feedback between population dynamics and evolution of interactions in a tri-trophic system”, Ref. HORIZON-ERC-STG-101042392, financed by European Union’s Horizon Europe research & innovation framework programme under Grant Agreement No. 101042392, under the following conditions:

1. **Scientific Area:** Biology
2. **Requirements for admission:** Bachelor in Biology. Demonstrated scientific and/or professional experience in entomology, namely of populations of spider-mites. Experience in planning and executing laboratorial experiments.
3. **Additional optional skills and qualifications:** a) Proficiency in English (written and spoken);  
b) Good organizational, multitasking and team work skills.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrollment in Master’s degree in Evolutionary Biology or similar.
5. **Work plan:** 1) Maintenance of experimental populations of spider-mites and predator-mites;  
2) Perform experiments to test which conditions affect predator-prey interactions;  
3) Ensure the proper functioning of the laboratory in general, namely the maintenance of stocks and all material associated with the project.  
The work plan is included in aims 1, 2 and 3 of the project DYNAMICTRIO: Feedback between population dynamics and evolution of interactions in a tri-trophic system.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16<sup>th</sup> December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12<sup>th</sup> May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](#)).
7. **Place of work:** The work will be developed at Centre for Ecology, Evolution and Environmental Changes (cE3c) at Faculty of Sciences, University of Lisbon under the scientific supervision of Professor Inês Fragata.
8. **Fellowship duration:** This position is initially opened for 6 months and due to start in December 2023. The fellowship contract may be potentially renewed for 6 months.
9. **Monthly allowance:** The fellowship amounts to € 1202,72, according to [table values](#) of the FCiências.ID Fellowship Regulation. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by Curriculum vitae – 60%, motivation letter – 40%.

Interview may be held to the 2 best evaluated candidates. In this case, the evaluation will be as follows: Curriculum vitae - 50%, motivation letter - 20% and interview - 30%.

Applicants whose application is scored with a final classification of less than 60 points are not eligible for granting a fellowship.

11. **Selection Committee:** President of the jury Inês Fragata Almeida; effective members: Inês Santos and Erik van Bergen, alternate members: Jessica King and Juan Adánez.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 09/11/2023 to 17/11/2023 .

14. **Application:** Applications should be sent via e-mail to [ifsantos@fc.ul.pt](mailto:ifsantos@fc.ul.pt), by attaching the following documents:

- a. Curriculum vitae;
- b. Certificate of completion of previous degree <sup>Note 1, 2</sup>;
- c. Motivation letter.

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

The personal data will be kept for the period necessary for the execution of the purposes for which they are intended, being ensured the processing and protection in an appropriate and diligent way, the confidentiality and integrity of these data, through appropriate technical and organizational measures.

Personal data may be transmitted to third parties, namely the entity funding the research project, solely for the purposes specifically established. 16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID ([fciencias.id@fciencias-id.pt](mailto:fciencias.id@fciencias-id.pt)) within 15 business days after the notification date

Their delivery is mandatory for the fellowship contractualization.
