

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### 1 (one) Research Fellowship (BI) for a MSc enrolled in a non-degree

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution “EpiCORK - Unveiling the role of DNA methylation in periderm and lenticel formation/BioISI”, “PTDC/ASP-SIL/1717/2020”, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme All Scientific Domains, under the following conditions:

1. **Scientific Area:** Biological Sciences, Agricultural Sciences
2. **Requirements for admission:** Master in Biology, Biochemistry, Biological Sciences, Biotechnology or a related area, with a final grade of 18 or higher.
3. **Additional optional skills and qualifications:** Preference will be given to candidates with:
  - a) previous experience in molecular biology of woody species (DNA/RNA extraction, PCR, primer design, cDNA synthesis, RT-qPCR) and plant phenotyping using fluorescence microscopy;
  - b) strong motivation for scientific research and progression to a PhD;
  - c) creativity, good communication skills and advanced English language.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in a non-degree course developed in association or cooperation between a High Education Institution and one or multiple research units.
5. **Work plan:** Participation in task 3 of the EpiCORK project, which includes the following plan:
  - (I) induction of DNA demethylation in cork oak seedlings using inhibitory drugs;
  - (II) quantification of global DNA methylation in treated and control plants;
  - (III) analysis of DNA methylation level and gene expression of candidate genes;
  - (IV) phenotypic analysis of the periderm by histology.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16<sup>th</sup> December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12<sup>th</sup> May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](#)).
7. **Place of work:** The work will be developed at the Forgen Lab – BioISI from Faculty of Sciences of the University of Lisbon under the scientific supervision of Professor Vera Inácio.
8. **Fellowship duration:** This position is initially opened for 6 months due to start in December 2023. The fellowship contract may be potentially renewed for until the end of the project, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.
9. **Monthly allowance:** The fellowship amounts to € 1199,64, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by Curriculum evaluation (master's degree final grade, publications in ISI journals, communications at conferences) - 40%; experience in the requested areas in paragraph 3. - 40%; and motivation letter - 20%.  
In case of a tie, an interview may be held. In this case, the appreciation will be Curriculum evaluation (final grade, publications in ISI journals, communications at conferences) - 25%; experience in the requested areas in paragraph 3. - 25%; motivation letter - 20%; and interview - 30%.  
Applicants whose application is scored with a final classification of less than 50 points are not eligible for granting a fellowship.
11. **Selection Committee:** The jury responsible for the selection will be constituted by:

- Effective members - Professor Célia Miguel and Professor Leonor Morais-Cecílio  
- Substitutes - Professor Anabela Bernardes da Silva e Doctor Pedro Barros
12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.
13. **Deadlines:** This call for applications is open from 15/11/2023 to 28/11/2023 .

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates' evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*.
