

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### 1 (one) Research fellowship (BI) for PhD student

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project “MATRIHEALTH - Extracellular matrix in health and disease”, financed by Private international funds, under the following conditions:

1. **Scientific Area:** 110000-MEDICAL AND HEALTH SCIENCES; Molecular and cellular biology
2. **Requirements for admission:** National, foreign and stateless candidates holding a Master's degree in Evolutionary and Developmental Biology, and have an average of at least 18 points (out of 20) in the Master's Degree, can apply for this research fellowship.
3. **Additional optional skills and qualifications:** 1) having at least one year of post-master laboratory experience; 2) have demonstrated knowledge in the area of oncobiology, in particular melanoma and the role of the extracellular matrix; 3) have experience in three-dimensional models using tumor cells (spheroids or others); 4) have experience in the following groups of laboratory techniques: I. animal cell cultures, II. processing of cells and tissues for immunohistochemistry and Western blot, III. microscopy and/or bioimaging techniques, and IV. basic molecular biology techniques (e.g. DNA cloning, PCR, RT-qPCR).  
The candidate must also have knowledge of English, good organizational skills and know how to work in a team. Participation in national and international scientific conferences will also be valued.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in PhD program in Biology, at Faculdade de Ciências da Universidade de Lisboa
5. **Work plan:** The extracellular matrix (ECM) is a network of non-cellular components that serves as a support for cells and tissues, providing structure and stability. Alterations in the components of the ECM have an important impact on processes such as proliferation, migration and adhesion, thus promoting tumorigenesis. However, one main question remains unanswered: can mutations in the genes encoding components of the ECM by themselves be key events for cancer onset and progression? Using the laboratory's extensive knowledge on the role of mutations in LAMA2, the gene encoding for the alpha chain of laminins 211 and 221, in the context of disease, this project aims to dissect whether and how LAMA2 deficiency can modulate tumorigenesis. To this end, it will make use of in vitro 2D and 3D models using melanoma cells as well as primary melanocytes carrying LAMA2 mutations.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16<sup>th</sup> December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12<sup>th</sup> May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](#)).
7. **Place of work:** The work will be developed at the Developmental and Evolutionary Morphogenesis (DEM) Laboratory of the Centre for Ecology, Evolution and Environmental Changes (cE3c) under the scientific supervision of Professor Ana Rita Carlos.
8. **Fellowship duration:** This position is initially opened for 12 months due to start in January 2024. The fellowship contract may be potentially renewed for 12 months.

9. **Monthly allowance:** The fellowship amounts to € 1199,64, according to [table values](#) of the FCIências.ID Fellowship Regulation. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

Additionally, it may be paid a tuition fees support grant (SAP) to support the costs with the annual tuition fees.

10. **Evaluation and selection process:** Candidates will be assessed by CV (80%), motivation letter (20%).

If necessary, an interview will be carried out with the 2 (two) best candidates. If there is an interview, the evaluation will be as follows: CV (60%), motivation letter (10%) and interview (30%).

Applicants whose application is scored with a final classification of less than 80 points are not eligible for granting a fellowship.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 21/11/2023 to 04/12/2023 .

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in
