

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### 1 (one) Research Fellowship (BI) for a Master enrolled in a non-degree course

Ref.: 437.4 – 1 BI ED CIRCLES

1 Research Fellowship(s) (BI) is (are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the Project “CIRCLES – Controlling mICRobiomes CircULations for bETter food Systems”, “Grant Agreement nº GA818290”, financed by European Union’s H2020 research and innovation programme, under the following conditions:

1. **Scientific Area:** Informatics.
2. **Requirements for admission:** MSc degree completed.
3. **Additional optional skills and qualifications:** Solid knowledge in advanced machine learning, in particular advanced clustering algorithms for temporal data.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrollment in a non-degree course developed in association or cooperation between a High Education Institution and one or multiple research units.
5. **Work plan:** The candidate will work in WP8 - Bioinformatics and systems biology: data storage, data integration and microbiome modelling [Months: 1-58 delayed 12 months due to Covid19]. In particular the work plan will be inserted in Task 8.5 Modelling of microbiomes across food chains in relation to covariates and metadata (task leader: FCID; participating: UNIBO, NVI, DTU) –the candidate will develop machine learning approaches to analyse covariates and temporal microbiome data from the project.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16<sup>th</sup> December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12<sup>th</sup> May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](https://www.fcicias.id/regulamento-de-bolsas-de-investigacao-cientifica-da-fcicias.id)).
7. **Place of work:** The work will be developed at LASIGE, Department of Informatics of the Faculty of Sciences of the University of Lisbon under the scientific supervision of Professor Sara C. Madeira and Helena Aidos.
8. **Fellowship duration:** This position is initially opened for 3 months and due to start in December 2023. The fellowship contract may be potentially renewed for until the end of the project, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P and FCiências.ID Fellowship Regulation.
9. **Monthly allowance:** The fellowship amounts to € 1199,64, according to [table values](#) of the FCiências.ID Fellowship Regulation. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by CV evaluation (70%); Knowledge in advanced machine learning (30%).

Applicants whose application is scored with a final classification of less than 85 points are not eligible for granting a fellowship.

11. **Selection Committee:** President of the jury: Sara C. Madeira; Members: Helena Aidos, Pedro Tomás; Alternate members: Cátia Pesquita, Andreia Sofia Teixeira.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 28/11/2023 to 07/12/2023 .

14. **Application:** Applications should be sent via e-mail to [lasige-candidaturas@listas.di.ciencias.ulisboa.pt](mailto:lasige-candidaturas@listas.di.ciencias.ulisboa.pt), indicating - otherwise it will not be considered eligible - in the "Subject": Ref. 437.4 – 1 BI ED CIRCLES, by attaching the following documents:

- c. other documents considered relevant.

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.
