

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### 1 (one) Research Fellowship (BI) for Master Student

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution “Arrows2cancer - Ruthenium-peptide conjugates: arrows for selectively targeting breast cancer/CQE”, “PTDC/QUI-QIN/0146/2020”, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme Programme All Scientific Domains, under the following conditions:

1. **Scientific Area:** Chemical Sciences, Inorganic Chemistry, Medicinal Chemistry
2. **Requirements for admission:** Candidates must have a degree in chemistry or related fields as a minimum, as well as relevant research experience in the field of inorganic/organometallic chemistry.
3. **Additional optional skills and qualifications:** Experience in the preparation of ruthenium-cyclopentadienyl organometallic compounds.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in Master.
5. **Work plan:** The work plan to be executed includes the following tasks: 1) Synthesis of new organometallic ruthenium complexes; 2) Structural characterization of the complexes by the usual spectroscopic techniques: FT-IR, UV-vis. and NMR. Elementary analyzes (%C, H%, N%, S%) will be also performed to obtain a guarantee of the purity of the compounds. Crystal structures will be determined by X-ray diffraction. 3) Synthesis of peptides and ruthenium-peptide conjugates (RuPCs); 4) The peptides and RuPCs will be purified and characterized by preparative HPLC, analytical HPLC and ESI-MS.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16<sup>th</sup> December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12<sup>th</sup> May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](#)).
7. **Place of work:** The work will be developed at the CQE-Centro de Química Estrutural, Departamento de Química e Bioquímica, Faculdade de Ciências da Universidade de Lisboa under the scientific supervision of Professor Tânia S. Morais.
8. **Fellowship duration:** This position is initially opened for 6 months due to start in January 2024. The fellowship contract may be potentially renewed for until the end of the project, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.
9. **Monthly allowance:** The fellowship amounts to € 930,98, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by the a) quality of their CV (50%), b) relevance of previous experience (35%) and c) motivation letter (15%). If necessary, the 3 candidates with the highest ranking will be called for an interview. If the interview is held, the final evaluation will be obtained considering the sum of the criteria a), b) and c) (90%) and the interview (10%).

Applicants whose application is scored with a final classification of less than 75 points are not eligible for granting a fellowship.

11. **Selection Committee:** President: Doctor Tânia Morais, Assistant researcher at FCIências.ID, Faculdade de Ciências da Universidade de Lisboa; 1st Member of the jury: Doctor Andreia Valente, Assistant researcher at Faculdade de Ciências da Universidade de Lisboa; 2nd Member of the jury: Professor Carla Nunes, Assistant professor at Departamento de Química e Bioquímica da Faculdade de Ciências da Universidade de Lisboa; 1st Alternate Member of the jury: Doctor Jaime Coelho, Assistant researcher at FCIências.ID, Faculdade de Ciências da Universidade de Lisboa; 2nd Alternate Member of the jury: Professor Maria José Brito, Assistant professor at Departamento de Química e Bioquímica da Faculdade de Ciências da Universidade de Lisboa.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 29/11/2023 to 14/12/2023 .
