

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### 1 (one) Research Fellowship (BI) for MSc enrolled in a non-degree course

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project “Blue Bioeconomy Pact – ALGAE VERTICAL”, financed by Notice n.º 02/C05-i01/2022 regarding the development of projects within the scope of the Mobilizing Agendas for Business Innovation, framed and financed under component n.º 5 - Capitalization and Business Innovation of the Recovery and Resilience in Portugal, under the following conditions:

1. **Scientific Area:** Applied Phycology

2. **Requirements for admission:**

1. MSc in Marine Environment and Resources, Marine Sciences or related fields.
  2. Demonstrated experience in microalgae research;
  3. Experience managing microalgae cultures at a laboratory scale;
  4. Experience in microalgae taxonomy;
  5. Experience in microalgae isolation methods;
  6. Scientific publications in the area of the competition, at least 2 as first author
- All the above must be detailed in the CV.

3. **Additional optional skills and qualifications:**

- a) Organized, enthusiastic and well-driven person that works well as a team.
  - b) Proficient in English both spoken and written;
  - c) Experience in molecular techniques applied to microalgae taxonomy and phylogeny;
  - d) Previous participation in national and/or international projects related to microalgae;
  - e) Experience in outreach activities in the scientific area of this competition;
- All the information should be provided in the CV.

4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in a non-degree course developed in association or cooperation between a High Education Institution and one or multiple research units.

5. **Work plan:** The work plan includes the following tasks:

- 1) Sampling, processing and isolating new microalgae strains to be included in the microalgae Biobank – of Lisbon University (ALISU) and Algae Vertical project.
- 2) Culture maintenance and management of microalgae at a laboratory scale.
- 3) Taxonomic identification of microalgae isolates using molecular methods, microscopy and chemotaxonomy.
- 4) Investigation of potential microalgae and microbiome interactions as a strategy for improving secondary metabolite production.
- 5) Introduction of new molecular methods and protocols in biobank maintenance, biodiversity evaluation and database construction;
- 6) Preparation and participation in project meetings and subsequent actions including project reports;
- 7) Writing and publication of results in peer-reviewed scientific journals and other means;
- 8) Participation in dissemination activities and science communication to the general public.
- 9) Provide support in other activities including laboratory management.

The work plan is included in Sub-Projects SP1a and SP1c of the Blue Bioeconomy Pact: Vertical Algae Project. The fellow is expected to interact with the other partners involved in the sub-tasks, namely “Bioprospection for novel

algae” and “Biobank establishment and maintenance”. Sampling tasks may be carried out along the entire Portuguese coast.

6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16<sup>th</sup> December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCIências.ID Fellowship Regulation, as approved on 12<sup>th</sup> May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCIências.ID](https://www.fciencias.id/regulamento-de-bolsas-de-investigacao-cientifica-da-fciencias.id)).

7. **Place of work:** The work will be developed at the Marine and Environmental Sciences Centre (MARE-ULisboa), at the Faculty of Sciences of the University of Lisbon under the scientific supervision of Professor Ana Amorim.

8. **Fellowship duration:** This position is initially opened for 6 months due to start in March 2024. The fellowship contract may be potentially renewed for 6 months, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P and FCIências.ID Fellowship Regulation.

9. **Monthly allowance:** The fellowship amounts to € 1 199,64, according to [table values](#) of the FCIências.ID Fellowship Regulation. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by the following criteria:

- a) Overall merit of CV 10%;
- b) Experience in microalgae research 10%;
- c) Experience in managing microalgae cultures at lab scale 10%;
- d) Experience in microalgae taxonomy 10%;
- e) Experience in isolating microalgae 10%;
- f) Scientific publications in the area of this call 10%;
- g) Proficient in English spoken and written 10%;
- h) Experience in molecular techniques applied to microalgae taxonomy 10%;
- i) Participation in scientific projects in the area of this call 10%;
- j) Participation in outreach activities 5%;
- k) Reference letter 5%.

The jury may decide to interview the 3 best ranked candidates [in criteria a) to k) of paragraph 10], for clarifications and improved explanations of curricular elements. If there is an interview, the sum of the classification obtained in the evaluation criteria a) to k) will correspond to 70% of the final classification and the interview will correspond to 30%.

Applicants whose application is scored with a final classification of less than 75 points are not eligible for granting a fellowship.

11. **Selection Committee:** President of the jury, Ana Amorim; 1st effective member, Carla Dias; 2nd effective member, Ricardo Melo; 1st alternate member, Vanda Brotas; 2nd alternate member, Catarina Guerreiro.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 10/01/2024 to 23/01/2024 .

14. **Application:** Applications should be sent via e-mail to [ccdias@ciencias.ulisboa.pt](mailto:ccdias@ciencias.ulisboa.pt), by attaching the following documents:

- a. Curriculum vitae;
- b. Certificate of completion of previous degree;
- c. At least one recommendation letter.

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

The personal data will be kept for the period necessary for the execution of the purposes for which they are intended, being ensured the processing and protection in an appropriate and diligent way, the confidentiality and integrity of these data, through appropriate technical and organizational measures.

Personal data may be transmitted to third parties, namely the entity funding the research project, solely for the purposes specifically established. 16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID ([fciencias.id@fciencias-id.pt](mailto:fciencias.id@fciencias-id.pt)) within 15 business days after the notification date

**Note 1:** The documents that prove the entitlement of the academic qualifications and diplomas, or the proof of registration in the academic degree or diploma requested on the call, can be dismissed during the application period and replaced by a declaration on their honour from the applicant. Their delivery is mandatory for the fellowship contractualization.

**Note 2:** Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
