

CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

1 (one) Research Fellowship (BI) for a Master enrolled in a non-degree course

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project “MATRIHEALTH – Extracellular matrix in health and disease”, financed by private international funding entity, under the following conditions:

1. **Scientific Area:** 110000-MEDICAL AND HEALTH SCIENCES; Molecular and cellular biology
2. **Requirements for admission:** . National, foreign and stateless candidates’ holders of the Bachelor's degree in Biotechnology and a Master’s degree in Molecular Biology and Genetics, and that have an average of at least 18 out of 20 in both degrees may apply for this fellowship.
3. **Additional optional skills and qualifications:** a) theoretical know-how and practical experience in skeletal muscle biology and associated diseases, as well as in molecular biology methodologies; b) experience in the following groups of laboratory techniques: I. animal cell culture, II. Processing of cells for immunohistochemistry and Western blot, III. microscopy and/or bioimaging techniques, IV. Experience in basic (e.g. PCR, RT-qPCR) advance (CRISPR-Cas9; use of viral vectors) molecular biology techniques; and V. experience of working the animal model *Mus musculus* (colony maintenance, handling of animals); c) Good level of English, good organization skills and teamwork ability.
Participation in scientific conferences and participation in scientific articles will be valued.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in non-degree course developed in association or cooperation between a High Education Institution and one or multiple research units, namely, the non-degree course in Scientific Research Methods and Techniques
5. **Work plan:** Extracellular matrices (ECMs) play a critical biochemical and structural role for cells and tissues. Their biochemical role is, for example, direct signalling through cell surface receptors or acting as a vehicle and reservoir for multiple factors, and their structural roles, help stabilize cells and tissues providing a solid-phase cell adhesion substrate. Mutations in ECM components can lead to the development of muscular dystrophies, namely LAMA2-CMD, a muscular dystrophy linked to mutations in LAMA2 gene, which encodes the alpha-2 chain of laminins 211 and 221, structural components of basement membranes. This project aims at establishing methodologies that allow to revert the phenotypes associated with LAMA2-CMD.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCIências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCIências.ID](#)).
7. **Place of work:** The work will be developed at the Developmental and Evolutionary Morphogenesis (DEM) group of the Centre for Ecology, Evolution and Environmental Changes (cE3c) under the scientific supervision of Professor Ana Rita Carlos.
8. **Fellowship duration:** This position is initially opened for 6 months due to start in March 2024. The fellowship contract may be potentially renewed for 6 months, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P and FCIências.ID Fellowship Regulation.

9. **Monthly allowance:** The fellowship amounts to € 1259,64, according to [table values](#) of the FCIências.ID Fellowship Regulation. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by CV (80%), motivation letter (20%). If necessary, an interview will be carried out with the 2 (two) best candidates. If there is an interview, the evaluation will be as follows: CV (60%), motivation letter (10%) and interview (30%). Applicants whose application is scored with a final classification of less than 80 points are not eligible for granting a fellowship.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 19/02/2024 to 28/02/2024 .

14. **Application:** Applications should be sent via e-mail to arcarlos@ciencias.ulisboa.pt, by attaching the following documents:

- a. Curriculum vitae;
- b. Certificate of completion of previous degree ^{Note 1, 2;}
- c. Motivation letter.

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

The personal data will be kept for the period necessary for the execution of the purposes for which they are intended, being ensured the processing and protection in an appropriate and diligent way, the confidentiality and integrity of these data, through appropriate technical and organizational measures.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in

Their delivery is mandatory for the fellowship contractualization.

Note 2: Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
