

CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

1 (one) Research Fellowship under Special Regime (BI-RE) for a MSc enrolled in a non-degree course

1 Research Fellowship(s) under Special Regime (BI-RE) is (are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the Project “SATO – Self Assessment Towards Optimisation of Building Energy”, financed by the European Union’s H2020 research and innovation programme under Grant Agreement no. 957128, under the following conditions:

1. **Scientific Area:** Computer Science
2. **Requirements for admission:** Portuguese, foreigners and stateless persons with a MSc degree in Computer Science Engineering.
3. **Additional optional skills and qualifications:** Experience in mobile application development considering IOS and Android targets, preferably with Meteor and React frameworks.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrollment in a non-degree course developed in association or cooperation between a High Education Institution and one or multiple research units.
5. **Work plan:** The work will be developed within WP2 to WP6 and WP8 of the SATO project, with the following work plan:
 - 1) Review of the architecture for the integration between mobile and web applications, the SATO platform and stakeholders endpoints;
 - 2) Design of data models to represent application entities;
 - 3) Implementation of mobile and web applications, integration with the SATO platform and stakeholders endpoints;
 - 4) Testing and validation of mobile and web applications.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCIências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCIências.ID](#)).
7. **Place of work:** The work will be developed at LASIGE, in Faculty of Sciences of the University of Lisbon under the scientific supervision of Professor José Manuel Cecílio (supervisor) and Ana Paula Afonso (co-supervisor).
8. **Fellowship duration:** This position is initially opened for 6 months and due to start in April 2024.
9. **Monthly allowance:** The fellowship amounts to € 1489,99, according to [table values](#) of the FCIências.ID Fellowship Regulation. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by the quality of their CV and possibly, a selection interview. If the selection interview is not carried out, the final evaluation will be obtained with a weighting of 100% in the curriculum evaluation. If the jury chooses to carry out the selection interview, it will be carried out to the 2 (two) candidates with the best classification in the curriculum evaluation. If the selection interview is carried out, the final evaluation will be obtained considering the following percentages: 70% for the curriculum evaluation and 30% for the selection interview

Applicants whose application is scored with a final classification of less than 75 points are not eligible for granting a fellowship.

11. **Selection Committee:** President - Prof. José Manuel Cecílio; Effective Member - Prof. Ana Paula Afonso; Effective Member - Prof. Pedro Miguel Ferreira; Alternate Member - Prof. Manuel J. Fonseca; Alternate Member - Prof. Guilherme Graça.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 04/03/2024 to 12/03/2024 .

14. **Application:** Applications should be sent via e-mail to cdrosa@fc.ul.pt, by attaching the following documents:

- a. Curriculum vitae;
- b. Certificate of completion of previous degree ^{Note 1, 2};
- c. other documents considered relevant.

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

The personal data will be kept for the period necessary for the execution of the purposes for which they are intended, being ensured the processing and protection in an appropriate and diligent way, the confidentiality and integrity of these data, through appropriate technical and organizational measures.

Personal data may be transmitted to third parties, namely the entity funding the research project, solely for the purposes specifically established. 16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date.

Note 2: Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
