

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### 1 (one) Research Fellowship (BI) for Master Student

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution “HAZARDOUS/IDL”, “PTDC/CTA-GEO/0798/2020”, “DOI: <https://doi.org/10.54499/PTDC/CTA-GEO/0798/2020>”, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme Programme All Scientific Domains, under the following conditions:

1. **Scientific Area:** Geography
  2. **Requirements for admission:** Bachelor’s degree in Geography.
  3. **Additional optional skills and qualifications:** The candidate should have executed projects (even if at academic level) in Photogrammetry. The candidate should have experience in following software: multiview photogrammetry, GIS, point cloud processing and remote sensing image classification. Experience in drone operations and field surveying with GNSS is of added value.
  4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in a Master in Geography or in another master in the geospatial area.
  5. **Work plan:** Geometric analysis of the evolution of the Fajãs in the Azores archipelago based on aerial photographs of drones.
  6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16<sup>th</sup> December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12<sup>th</sup> May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](#)).
  7. **Place of work:** The work will be developed at the Instituto Dom Luiz (IDL), Faculdade de Ciências da Universidade de Lisboa under the scientific supervision of Professor Paula Maria Ferreira de Sousa Cruz Redweik.
  8. **Fellowship duration:** This position is initially opened for 6 months due to start in May 2024. The fellowship contract may be potentially renewed for until the end of the project, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.
  9. **Monthly allowance:** The fellowship amounts to € 990,98, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.
  10. **Evaluation and selection process:** Candidates will be assessed by the quality of their CV 100% (60% for the Bachelor’s degree average and 40% for the experience in projects and software defined in paragraph 3. Additional optional skills and qualifications). And in case the jury considers it necessary, an interview will be held to the three best classified candidates. In this case, the final note will be a weighted average of the CV analysis (75%) and the interview (25%).
- Applicants whose application is scored with a final classification of less than 65 points are not eligible for granting a fellowship.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 17/04/2024 to 02/05/2024 .

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates' evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID ([fciencias.id@fciencias-id.pt](mailto:fciencias.id@fciencias-id.pt)) within 15 business days after the notification date.

**Note 1:** The documents that prove the entitlement of the academic qualifications and diplomas can be dismissed during the application period and replaced by a declaration on their honour from the applicant ([Minuta PT](#), [Minute EN](#)). Their delivery is mandatory for the fellowship contractualization.

**Note 2:** Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
