

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### 1 (one) Research Fellowship (BI) for a MSc student

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution “MARE – Centro de Ciências do Mar e do Ambiente”, “grant agreement number UIDB/04292/2020”, “DOI: <https://doi.org/10.54499/UIDB/04292/2020>”, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme financiamento plurianual 2020-2023 da Unidade de I&D MARE – Centro de Ciências do Mar e do Ambiente, under the following conditions:

1. **Scientific Area:** Biology
2. **Requirements for admission:** Degree in Biology. At least 3 years' experience in the in situ identification of coastal organisms with special emphasis on macrofauna and intertidal flora. At least 3 years' experience in ocean literacy activities/projects involving students and teachers. Certification and practical experience in work/activities involving autonomous scuba diving.
3. **Additional optional skills and qualifications:** Ability and motivation to work in a multidisciplinary team. Preference is given to candidates with a driver's license and own vehicle due to the fieldwork. Immediate availability to start the research fellowship. Oral communication skills in Portuguese and English.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in Master's degree in Biology, Marine Biology, Conservation Biology or similar.
5. **Work plan:** The work plan will include presentations of the MARE educational program to the students (8-17 years old) and teachers; carrying out the field activities in the intertidal zone scheduled for the program and coordinating the groups of students during the field trips; participation and logistical support in the pool diving activities; drawing up session plans for new activities to be developed in the future; analysis of quantitative data from the surveys carried out with all the participants in this educational project.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16<sup>th</sup> December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12<sup>th</sup> May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](#)).
7. **Place of work:** The work will be developed at the MARE at the Faculty of Sciences of Lisbon University under the scientific supervision of Professor Miguel Pais.
8. **Fellowship duration:** This position is initially opened for 6 months due to start in May 2024. The fellowship contract may be potentially renewed for until the end of the project, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.
9. **Monthly allowance:** The fellowship amounts to € 990,98, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by a) Curriculum evaluation (80%) and b) motivation letter (20%). The jury may conduct an interview with the top 3 (three) candidates based on the total scores of criteria a) and b). If there is an interview, the sum of the classification obtained in the evaluation criteria a) and b) will correspond to 70% of the final classification and the interview will correspond to 30%. Applicants whose application is scored with a final classification of less than 70 points are not eligible for granting a fellowship.

11. **Selection Committee:** Ricardo Melo (President of the Jury), Miguel Pais (Effective Member), Frederico Almada (Effective Member), Helena Adão (Alternate Member) and Ana Faria (Alternate Member).

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 23/04/2024 to 08/05/2024.

14. **Application:** Applications should be sent via e-mail to [mare@mare-centre.pt](mailto:mare@mare-centre.pt), by attaching the following documents:

- a. Curriculum vitae;
- b. Certificate of completion of previous degree <sup>Note 1, 2;</sup>
- c. Motivation letter;
- d. Open Water Diver (OWD) certificate.

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

The personal data will be kept for the period necessary for the execution of the purposes for which they are intended, being ensured the processing and protection in an appropriate and diligent way, the confidentiality and integrity of these data, through appropriate technical and organizational measures.

Personal data may be transmitted to third parties, namely the entity funding the research project, solely for the purposes specifically established. In this sense, whenever the transfer of personal data to countries outside the European Union and/or international organizations is necessary, compliance with the applicable legal provisions is ensured.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates' evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID ([fciencias.id@fciencias-id.pt](mailto:fciencias.id@fciencias-id.pt)) within 15 business days after the notification date.

**Note 1:** The documents that prove the entitlement of the academic qualifications and diplomas can be dismissed during the application period and replaced by a declaration on their honour from the applicant ([Minuta PT](#), [Minute EN](#)). Their delivery is mandatory for the fellowship contractualization.
