2 (two) Research Fellowships (BI) for MSc Student or BSc enrolled in a non-degree course

2 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution “LASIGE”, UIDP/00408/2020”, “DOI: <https://doi.org/10.54499/UIDP/00408/2020>”, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme Programmatic Funding 2020-23, under the following conditions:

1. **Scientific Area:** Computer Science and Engineering.
2. **Requirements for admission:** BSc completed.
3. **Additional optional skills and qualifications:** Enrolment in the second year of a master's degree at the Department of Informatics of the Faculty of Sciences of the University of Lisbon or in non-degree course developed in association or cooperation between a High Education Institution and one or multiple research units, namely in the area of informatics or related field.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in master's degree in the area of informatics or related field, or in non-degree course developed in association or cooperation between a High Education Institution and one or multiple research units, namely in the area of informatics or related field.
5. **Work plan:** Development of a research project within one or more research lines of LASIGE (<https://www.lasige.pt>), under the scientific supervision of a PhD member of LASIGE.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml>), and FCIências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCIências.ID](#)).
7. **Place of work:** The work will be developed at the LASIGE, Department of Informatics of the Faculty of Sciences of the University of Lisbon under the scientific supervision of a PhD member of LASIGE.
8. **Fellowship duration:** This position is initially opened for 6 months due to start in July 2024. The fellowship contract may be potentially renewed for until the end of the project and for a maximum of another 6 months, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.
9. **Monthly allowance:** The fellowship amounts to € 990,98, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by 1. Merit of the Applicant (60%), of which the academic career (reflecting the academic degree grades) with a weighting of 50%, and personal curriculum (reflecting the scientific and professional career, and academic career), with a weighting of 50%.

2. Merit of the Work Plan (40%).

Applicants whose application is scored with a final classification of less than 75 points are not eligible for granting a fellowship.

11. **Selection Committee:** President: Alysson Bessani; Members: Antónia Lopes, Carlos Duarte; Alternate members: Bernardo Ferreira, Cátia Pesquita.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 28/05/2024 to 12/06/2024 .

14. **Application:** Applications should be sent via e-mail to lasige-candidaturas@listas.di.ciencias.ulisboa.pt, indicating - otherwise they will not be considered eligible - in the "Subject": Ref. 816.5 – 2 BI EM LASIGE, by attaching the following documents:

- Curriculum vitae, with the mandatory inclusion of the degrees obtained and/or to be attended, curricular units, respective grades and ECTS;
- Certificate of completion of previous degree* ^{Note 1, 2,}
- Detailed research work plan. The plan should be composed of the following sections: i) Description of activities; ii) Milestones and planned outputs; iii) Impact (a presentation of the potential of the candidate and their work plan to sustain future research opportunities supported by funding (e.g. PhD scholarships, national or international projects, collaborations with companies, etc.);
- Document exemplifying the candidate's scientific writing (article, report or thesis, among others);
- Letter of recommendation (it should justify the framework of the work in one or more of LASIGE's research lines, <https://www.lasige.pt>);
- Filled application form, available at:

- Letter(s) of recommendation signed by the supervisor(s) of the research project(s) (if mentioned as having research experience in the application form).

*Foreign certificates must be accompanied by proof of conversion of the final classification

15. **Processing of personal data:** FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

The personal data will be kept for the period necessary for the execution of the purposes for which they are intended, being ensured the processing and protection in an appropriate and diligent way, the confidentiality and integrity of these data, through appropriate technical and organizational measures.

Personal data may be transmitted to third parties, namely the entity funding the research project, solely for the purposes specifically established. In this sense, whenever the transfer of personal data to countries outside the European Union and/or international organizations is necessary, compliance with the applicable legal provisions is ensured.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates' evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date.

Note 1: The documents that prove the entitlement of the academic qualifications and diplomas can be dismissed during the application period and replaced by a declaration on their honour from the applicant ([Minuta PT](#), [Minute EN](#)). Their delivery is mandatory for the fellowship contractualization.

Note 2: Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
