

CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

1 (one) Research Fellowship (BI) for a Master Student

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution “BioISI - Biosystems & Integrative Sciences Institute”, “Ref. UIDB/04046/2020”, “DOI: <https://doi.org/10.54499/UIDB/04046/2020>”, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme Strategic Project, under the following conditions:

1. **Scientific Area:** Biology
2. **Requirements for admission:** BSc degree in Biology or related areas, with work experience in the context of research laboratories in the area of Cell and Molecular Biology for more than one year. Experience in human cell culture with a minimum of 40 hours of supervised training and more than 6 months of independent use. Experience in isolation of primary human cells, staining and analysis by flow cytometry. Experience in laboratory management and organization. Proficiency in spoken and written English, at level B1 of the Common European Framework of Reference for Languages.
3. **Additional optional skills and qualifications:** Rigor, organization and ability to work within a team. Experience in technical support for laboratory research activities. Experience in the following techniques: culture of immortalized adherent and myeloid cell lines and primary cells; isolation of lymphocytes from blood; activation of lymphocytes in vitro. Transfection of cells by chemical and electroporation methods. Histological staining and immunofluorescence. Cell sorting. Training in flow cytometry data analysis, with preference for the FCS Express software. Experience working in an international environment.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in Master.
5. **Work plan:** Periodic performance of contamination detection tests in cell line cultures; Culture of adherent and myeloid immortalized cell lines and primary cells; Isolation of lymphocytes from blood and in vitro lymphocyte activation. Cell transfection by chemical methods and electroporation; Histological and immunofluorescence staining; Cell sorting. Support in the organisation and maintenance of BioISI's cell culture infrastructure, as well as BioISI's laboratory equipments.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml>), and FCIências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCIências.ID](#)).
7. **Place of work:** The work will be developed at the BioISI - Biosystems & Integrative Sciences Institute - Ciências ULisboa under the scientific supervision of Professor Margarida Gama-Carvalho.
8. **Fellowship duration:** This position is initially opened for 3 months due to start in July 2024. The fellowship contract may be potentially renewed for until the end of the project, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.
9. **Monthly allowance:** The fellowship amounts to € 990,98, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the

right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by a) CV evaluation (70%), b) motivation letter (20%), c) recommendation letter (10%). The jury may choose to conduct an interview with the top 2 (two) classified candidates (total of criteria a) to c), aimed at obtaining clarifications, additional information and/or explanation of elements presented. In this case, the sum of the evaluations obtained in criteria a) to c) will correspond to 70% of the final classification and the interview to 30%.

Applicants whose application is scored with a final classification of less than 80 points are not eligible for granting a fellowship.

11. **Selection Committee:** President of the jury – Rui Malhó, 1^o effective member - Margarida Gama-Carvalho 2^o effective member – Carlos Farinha; 1^o Alternate member – Patrícia Faísca; 2^o Alternate member – Margarida Amaral.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 06/06/2024 to 21/06/2024 .

14. **Application:** Applications should be sent via e-mail to Bioisidirector@ciencias.ulisboa.pt, by attaching the following documents:

- Curriculum vitae;
- Certificate of completion of previous degree ^{Note 1, 2;}
- Letter of motivation;
- Letter of recommendation from a previous supervisor/employer with specific reference to the candidate's qualities in laboratory research activities in the area;
- Certificate of English Level (except English native speaker).

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

The personal data will be kept for the period necessary for the execution of the purposes for which they are intended, being ensured the processing and protection in an appropriate and diligent way, the confidentiality and integrity of these data, through appropriate technical and organizational measures.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates' evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date.

Note 1: The documents that prove the entitlement of the academic qualifications and diplomas can be dismissed during the application period and replaced by a declaration on their honour from the applicant ([Minuta PT](#), [Minute EN](#)). Their delivery is mandatory for the fellowship contractualization.

Note 2: Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
