

CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

1 (one) Research Fellowship (BI) for Master Student

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution “Randomised controlled trial and economic evaluation of a person-centred digital intervention to prevent diabetes in high-risk adults”, “2022.02969.PTDC”, “DOI: <https://doi.org/10.54499/2022.02969.PTDC>”, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme Programme All Scientific Domains, under the following conditions:

1. **Scientific Area:** Informatics
2. **Admission requirements:** Candidates must have the following mandatory requirements: Hold a degree in Computer Engineering, Information Technologies or a similar field; and have taken courses in the areas of Web Technologies, Artificial Intelligence, Computer Graphics and Human-Computer Interaction.
3. **Additional optional skills and qualifications:** Preference will be given to candidates with experience in web application development; with good performance in the disciplines of the areas required in the admission requirements; and with good knowledge of Portuguese and English. Experience with tools used in the mentioned areas is also a distinguishing factor, but not mandatory.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in a master’s degree in the area of Informatics.
5. **Work plan:** The work consists of the development of some modules for a Web application to be used by people at high risk of getting Type 2 Diabetes, so that they can be helped to prevent this disease. More specifically, this work focuses mainly on the application modules corresponding to the implementation of the virtual assistant that dialogues with users and to the development of a dashboard component that allows the monitoring and visualization of the various dimensions of each user's activity. The work will also involve the participation in evaluation tasks involving potential end users.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](#)).
7. **Place of work:** The work will be developed at the LASIGE research unit, Departamento de Informática, under the scientific supervision of Professor João Balsa da Silva (supervisor) and Professor Maria Beatriz Carmo (co-supervisor).
8. **Fellowship duration:** This position is initially opened for 3 months due to start in October 2024. The fellowship contract may be potentially renewed for 4 months.
9. **Monthly allowance:** The fellowship amounts to € 990,98, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by CV, motivation letter and an optional interview. The final classification (from 0 to 100 points) will be obtained considering the following weights: a) CV – 70%; b) motivation letter – 30%.
The jury may conduct an interview with the top 3 (three) candidates in total of criteria a) and b). If there is an interview, the final evaluation will be obtained considering the following percentages: a) CV (70%), b) motivation letter (10%), c) interview (20%).
Applicants whose application is scored with a final classification of less than 50 points are not eligible for granting a fellowship.
11. **Selection Committee:** President of the Jury: Prof. João Balsa da Silva; effective members: Professors Maria Beatriz Carmo and Ana Paula Cláudio; alternate members: Professors Paulo Urbano and Luis Moniz.
12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.
13. **Deadlines:** This call for applications is open from 11/09/2024 to 24/09/2024 .
14. **Application:** Applications should be sent via e-mail to jbalsa@ciencias.ulisboa.pt, by attaching the following documents:
- a. Curriculum vitae;
 - b. Certificate of completion of previous degree ^{Note 1, 2;}
 - c. Motivation letter.
15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates' evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date.
