

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### 1 (one) Research Fellowship (BI) for a PhD student or a MSc enrolled in a non-degree course

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution “NanoBioMitig: Nanoengineering systems designed with natural phytochemicals to mitigate biofouling on industrial surfaces/BioISI-Biosystems and Integrative Sciences Institute”, “2022.06149.PTDC”, “DOI: <https://doi.org/10.54499/2022.06149.PTDC>”, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme Call for R&D Projects in All Scientific Domains - 2022, under the following conditions:

1. **Scientific Area:** Chemical Sciences
2. **Admission requirements:** Master's degree in the scientific field of Chemical Sciences.
3. **Additional optional skills and qualifications:**
  - a) Fluency in English (written and spoken) - information provided in the CV and/or motivation letter.
  - b) Proven experience in the synthesis of compounds preferably with ability to handle compounds under inert atmosphere conditions - information provided in the CV and/or motivation letter.
  - c) Proven experience in characterization techniques of compounds, namely by FTIR, NMR, UV-Vis and X-ray diffraction - information provided in the CV and/or motivation letter.
  - d) Scientific experience demonstrated through publications in peer-reviewed scientific journals within the scope and requirements of work plan - information provided in the CV and/or motivation letter.
  - e) Proven experience in dissemination activities in the scientific area(s) of this competition - information provided in the CV and/or motivation letter.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in a PhD programme or non-degree course developed in association or cooperation between a High Education Institution and one or multiple research units.
5. **Work plan:**

The work plan to be carried out includes the following tasks:

  - a) Synthesis, functionalization, and characterization of materials;
  - b) Development of bioactive coatings and their characterization.
  - c) Support in publishing results in peer-reviewed scientific journals and other means;
  - d) Participation in dissemination activities, communication, and engagement of project stakeholders.
  - e) Writing periodic reports.

The work plan is distributed across tasks 1, 4, 5, and 6 of the NanoBioMitig project.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16<sup>th</sup> December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12<sup>th</sup> May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](https://www.fciencias.id/regulamento-de-bolsas-de-investigacao-cientifica-da-fciencias.id)).
7. **Place of work:** The work will be developed at the BioISI - BioSystems and Integrative Sciences Institute, Faculty of Sciences of the University of Lisbon under the scientific supervision of Professor Elisabete Ribeiro Silva.
8. **Fellowship duration:** This position is initially opened for 3 months due to start in January 2025. The fellowship contract may be potentially renewed for 3 months.

9. **Monthly allowance:** The fellowship amounts to € 1259,64, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by a) evaluation of the Curriculum Vitae (90%), b) motivation letter (5%), c) recommendation letter (5%). Interview for the first 3 (three) candidates if considered necessary by the jury. In case an interview takes place, the sum obtained in the evaluation of criteria a) to c) will correspond to 80% of the final classification and the interview will correspond to 20%.

Applicants whose application is scored with a final classification of less than 65 points are not eligible for granting a fellowship.

11. **Selection Committee:** Dr. Elisabete R. Silva (President), Professor Bernardo Duarte (1st effective member), Dr. Ana P. Carapeto (2nd effective member), Professor Manuela Pereira (1st alternate member), Professor Vanessa Fonseca (2nd alternate member).

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 24/10/2024 to 07/11/2024 .

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates' evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID ([fciencias.id@fciencias-id.pt](mailto:fciencias.id@fciencias-id.pt)) within 15 business days after the notification date.

**Note 1:** The documents that prove the entitlement of the academic qualifications and diplomas can be dismissed during the application period and replaced by a declaration on their honour from the applicant ([Minuta PT](#), [Minute EN](#)). Their delivery is mandatory for the fellowship contractualization.

**Note 2:** Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
