3 (three) Research Fellowships for R&D Initiation (BII) for Bachelor Students

3 Research Fellowship(s) for R&D Initiation (BII) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project “Accelerat.AI, Ref. C644865762-00000008”, financed by IAPMEI and European Union - Next Generation EU Fund within the scope of call for proposals no. 02/C05-i01/2022 - submission of final Proposals for Project Development under the Mobilizing Agendas for Business Innovation of the Recovery and Resilience Plan, under the following conditions:

1. **Scientific Area:** Artificial Intelligence
2. **Admission requirements:**
 - a) Proficiency in the Python programming language - information to be provided in the CV;
 - b) Proficiency in Portuguese (spoken and written), in the European variant, at level C2 of the Common European Framework of Reference for Languages, certified with the respective diploma, or as a mother tongue, since this is a project that aims to develop conversational agents in Portuguese, European variant, and it is essential that the candidate is able to evaluate their performance - to be provided in the CV,
3. **Additional optional skills and qualifications:** cumulatively or alternatively:
 - a) Experience and vocation for the creation of datasets in European Portuguese for Humour-aware Information Retrieval and claim detection tasks - information to be provided in the CV and motivation letter;
 - b) Previous experience in Research and Development (R&D) projects in the field of Natural Language Processing - information to be provided in the CV and motivation letter;
 - c) Previous experience in implementing information retrieval systems - information to be provided in the CV and motivation letter;
 - d) Previous experience using models available on the Hugging Face platform - information to be provided in the CV and motivation letter;
 - e) Previous experience in scientific competitions, namely CLEF - information to be provided in the CV and motivation letter;
 - f) Experience in adapting computational resources from English to European Portuguese - information to be provided in the CV and motivation letter;
 - g) Solid knowledge of tools for developing CI/CD pipelines, especially GitHub Actions - information to be provided in the CV and motivation letter;
 - h) Having passed or recently attended a course on Artificial Intelligence - information to be provided in the CV and motivation letter.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in BSc in Informatics Engineering.
5. **Work plan:**
 - 1) With the maximum level of autonomy and capacity framed in this Research Fellowship for R&D Initiation, cutting-edge research on Artificial Intelligence applied to Language Technology for conversational agents in view of multimodal information processing including the development of neural models for language and image using deep learning technology, with particular focus on the Portuguese language;
 - 2) Preparation and participation in project meetings and subsequent actions;
 - 3) Preparation of articles and publication of results;

4) Participation in the dissemination activities of the project.

The work plan is included in Activity 2.1 and 2.2 of the project Accelerat.ai: Multilingual Intelligent Contact Centers.

6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCIências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCIências.ID](https://www.fciencias.id/regulamento-de-bolsas-de-investigacao-cientifica-da-fciencias.id)).

7. **Place of work:** The work will be developed at the NLX – Natural Language and Speech Research Group of the Faculdade de Ciências da Universidade de Lisboa or at the Grupo de Processamento de Linguagem Natural do Núcleo do INESC-TEC of the Universidade da Beira Interior under the scientific supervision of Professor António Branco (supervisor) and Ricardo Campos (co-supervisor).

8. **Fellowship duration:** This position is initially opened for 6 months due to start in January 2025. The fellowship contract may be potentially renewed for until the end of the project, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P and FCIências.ID Fellowship Regulation.

9. **Monthly allowance:** The fellowship amounts to € 601,12, according to [table values](#) of the FCIências.ID Fellowship Regulation. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by

1. Failure to fulfil the Admission Requirements is sufficient reason for candidates not to be admitted on absolute merit.

2. The final classification system for candidates is expressed on a scale of 0 to 100 per cent.

3. The assessment criteria for relative merit are:

a) Level of satisfaction of the additional optional skills and qualifications - 40%;

b) Alignment of the motivation letter with the work plan - 25%;

c) Proficiency in the working language - 35%;

d) Interview, if deemed necessary by the jury. If there is an interview, the sum of the classification obtained in the evaluation criteria a) to c) will correspond to 90% of the final classification and the interview will correspond to 10%.

4. The jury reserves the right not to award the fellowship if the profile of the candidates is not suitable.

Applicants whose application is scored with a final classification of less than 80 points are not eligible for granting a fellowship.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 20/12/2024 to 10/01/2025 .

14. **Application:** Applications should be sent via e-mail to bolsas@gmx.com, indicating - otherwise they will not be considered eligible – in the Subject “1148 – 3 BII EL”, by attaching the following documents:
- Curriculum vitae;
 - Certificate of completion of previous degree ^{Note 1, 2};
 - Motivation letter;
 - Other documents considered relevant.

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date.

Note 1: The documents that prove the entitlement of the academic qualifications and diplomas can be dismissed during the application period and replaced by a declaration on their honour from the applicant ([Minuta PT](#), [Minute EN](#)). Their delivery is mandatory for the fellowship contractualization.

Note 2: Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
