



## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### (4 Post-Doc Fellowships)

DL is an Associated Laboratory of the Portuguese Ministry of Education and Science, hosted by the University of Lisbon, and devoted to Earth System Science.

4 Post-Doc Fellowships are opened **at the Instituto Dom Luiz - Universidade de Lisboa**, in the project I&D, Incentivo/CTE/LA0019/2014, financed by national funds by FCT / MEC (PIDDAC) under the (Incentivo) *Strategic Programme 2013-2014*, under the following conditions:

1. **Scientific Area:** Geosciences
2. **Requirements for admission:** hD in a subarea of Geosciences (Meteorology, Solid Earth Geophysics, Physical Oceanography, Geology and related subjects), preferably with a record of publications in international refereed journals.
3. **Work plan:** Each of the Post-Docs will be integrated in one of the following ongoing IDL research groups:
  - (a) **Atmosphere-Ocean processes and Climate Modelling;**
  - (b) **Climate Change, variability and Extremes;**
  - (c) **Coast, Water and Surface Processes;**
  - (d) **Marine Geology and Geophysics;**
  - (e) **Earthquakes, Volcanism and Lithospheric Processes;**
  - (f) **Sedimentary Systems, Paleoecology and Paleobiodiversity;**
  - (g) **Chemical geodynamics and multidisciplinary research on geological resources;**
  - (h) **Sustainable Energy.**

One of the positions may be filled by a Geoscientist willing to work on Outreach.  
Each Candidate must propose a specific project to be included in one of the aforementioned groups. The project must be written in up to 2 A4 pages, including references.
4. **Legislation framework:** A fellowship contract will be celebrated according to the regulations defined by FCT "Regulations for Advanced Training and Qualification of Human Resources", in accordance with Law 40/2004, of 18 August, as amended and republished by Decree-Law No. 202/2012 of 27 August, and as amended by Decree-Law No. 233/2012 of 29 October and by Law No. 12/2013, of January 29, and Decree-Law No. 89/2013 of 9 July. And also by the FCT, I.P. Fellowships Regulation of 2013 approved by Regulation No. 234/2012, of June 25, as amended by Regulation No 326/2013 of 27 August 2013, in force ([www.fct.pt/apoios/bolsas/regulamento.phtml.pt](http://www.fct.pt/apoios/bolsas/regulamento.phtml.pt))
5. **Place of work:** The work will be developed at IDL, University of Lisbon, under the scientific guidance of the corresponding Group Coordinator. (a) Álvaro Peliz; (b) Ricardo Trigo; (c) César Andrade; (d) Maria Ana Baptista; (e) Susana Custódio; (f) Ana Azeredo; (g) António Mateus; (h) João Serra.
6. **Fellowship duration:** This position is initially opened for 6 months however it could be renew for more 2 month and will begin on May 2014.
7. **Monthly allowance:** The fellowship amounts to € 1495, according to table values of the fellowships awarded directly by the FCT, IP. (<http://www.fct.pt/apoios/bolsas/valores>).  
The fellowship holder will have a personal accident insurance and, if not covered by any social protection scheme can ensure the right to social security through adherence to the voluntary social insurance scheme, pursuant to Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social.

The fellowship will be paid monthly by bank transfer.

8. **Selection method:** Candidates will be assessed by the quality of their CV (50%) and on the evaluation of an interview (50%) - please notice that if *EU non residents are predicted to apply to the fellowship, an interview (via skype is acceptable) should be included in the selection procedure as, otherwise, a non EU candidate that does not have a Portuguese resident visa to whom no interview was conducted will not be eligible. (see Regulation of Research Fellowships from the Foundation for Science and Technology, I.P. - 2013, article 14, b) and c).*

10. **Publication/notification of results:** The final results of the evaluation will become public, through ordered list which will be posted at the entrance hall of the **Instituto Dom Luiz**, located at the Faculdade de Ciências da Universidade de Lisboa, C8 – 3<sup>rd</sup> floor, Campo Grande, 1749-016 Lisboa, and the selected candidate will be notified by *e-mail*.
11. **Deadlines:** This call for applications is open from 11<sup>th</sup> to 28<sup>th</sup> April 2014.
