

CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

1 (one) Research Fellowship (BI) for Master student

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project “LSA SAF CDOP4: Land Surface Analysis - Fourth Continuous Development and Operations Phase”, financed by EUMETSAT, a Agência Europeia para a Exploração de Satélites Meteorológicos, under the following conditions:

1. **Scientific Area:** Geosciences

2. **Admission requirements:** Degree in Physics.

The candidate must have previous experience with remote sensing data, data from numerical weather prediction models, and handling large databases; as well as solid mathematical and programming skills, particularly in the use of MATLAB and Python, and knowledge about wildfires. Candidates who do not meet these requirements will be excluded.

3. **Additional optional skills and qualifications:** Proven experience in programming (MATLAB and Python); knowledge of data processing and handling; experience in mathematical modeling, especially dynamic systems.

4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in masters programme.

5. **Work plan:** Assist the project team in achieving its objectives, in particular: 1) writing product support documentation; 2) monitoring and validating the quality of the products distributed; 3) maintaining the burnt area detection tool.

6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCIências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCIências.ID](https://www.fciencias.id/regulamento-de-bolsas-de-investigacao-cientifica-da-fciencias.id)).

7. **Place of work:** The work will be developed at the Laboratório Associado Instituto Dom Luiz (IDL), Faculdade de Ciências da Universidade de Lisboa under the scientific supervision of Professor Carlos da Camara.

8. **Fellowship duration:** This position is initially opened for 6 months due to start in May 2025. The fellowship contract may be potentially renewed for until the end of the project, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P and FCIências.ID Fellowship Regulation.

9. **Monthly allowance:** The fellowship amounts to € 1 040,98, according to [table values](#) of the FCIências.ID Fellowship Regulation. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by Curriculum Vitae (20%), motivation letter (10%), programming experience (MATLAB and Python) (30%), knowledge and experience with mathematical modelling (30%) and knowledge of data acquisition and processing (10%). Applicants whose application is scored with a final classification of less than 80 points are not eligible for granting a fellowship.

11. **Selection Committee:** Prof. Doutor Carlos da Camara (President of the jury); Prof. Doutor Ricardo Trigo (effective member); Prof. Doutor Pedro Soares (effective member); Doutor Virgílio Bento (alternate member) and Doutora Célia Gouveia (alternate member).

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 16/05/2025 to 26/05/2025 .

14. **Application:** Applications should be sent via e-mail to cdcamara@fc.ul.pt, by attaching the following documents:

- a. Curriculum vitae;
- b. Certificate of completion of previous degree ^{Note 1, 2;}
- c. Motivation letter.

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date.
