

CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

1 (one) Research Fellowship (BI) for a MSc enrolled in a non-degree course

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project “A highly sensitive, probe-free and non-invasive immunotherapy biomarker for CAR-T fitness”, “LISBOA2030-FEDER-00668300”, co-financed by Lisboa2030, Portugal2030 and the European Union, and by Nacional Funds through Fundação para a Ciência e a Tecnologia, I.P, under the following conditions:

1. **Scientific Area:** Biochemistry
2. **Admission requirements:** Master degree in Biochemistry or related fields. Experience in calorimetry, flow cytometry and isolation of PBMC cells.
3. **Additional optional skills and qualifications:** Good spoken and written knowledge of Portuguese and English.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas, if applicable. Enrolment in non-degree course developed in association or cooperation between a High Education Institution and one or multiple research units.
5. **Work plan:** The overall goal of the project is to test whether heat is a biomarker for cell fitness in the context of cell therapies. The fellow will perform the experiments on PBMC cells isolated from human donors from the Portuguese Institute of Blood and Transplantation, I.P. These cells will be transformed and subjected to environmental stresses to test the working hypothesis.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCIências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCIências.ID](#)).
7. **Place of work:** The work will be developed at the CQE – Centro de Química Estrutural, CIÊNCIAS ULISBOA, under the scientific supervision of Professor Fernando José Nunes Antunes.
8. **Fellowship duration:** This position is initially opened for 6 months due to start in July 2025. The fellowship contract may be potentially renewed for 6 months, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P and FCIências.ID Fellowship Regulation.
9. **Monthly allowance:** The fellowship amounts to €1040,98, according to [table values](#) of the FCIências.ID Fellowship Regulation. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.
10. **Evaluation and selection process:** Candidates will be assessed by
 - a) Cover letter, with a brief description of the candidate's experience and motivation (10%);
 - b) CV, considering the diploma, and its relevance to the project (45%);
 - c) Relevance and suitability of previous research and experience for the work plan (45%).

Applicants whose application is scored with a final classification of less than 80 points are not eligible for granting a fellowship.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 06/06/2025 to 24/06/2025 .

14. **Application:** Applications should be sent via e-mail to fantunes@fc.ul.pt, by attaching the following documents:

- a. Curriculum vitae;
- b. Certificate of completion of previous degree ^{Note 1, 2;}
- c. Cover letter, with a brief description of the candidate's experience and motivation.

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date.
