

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### 1 (one) Research Fellowship (BI) for a PhD Student

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution “AldentifyAGE – Artificial Intelligence and its Application by Forensic Science Service Providers: Migrant Unidentified Age Estimation”, “2024.07444.IACDC”, “DOI: <https://doi.org/10.54499/2024.07444.IACDC>”, supported by measure “RE-C05-i08.M04 – “Apoiar o lançamento de um programa de projetos de I&D orientado para o desenvolvimento e implementação de sistemas avançados de cibersegurança, inteligência artificial e ciência de dados na administração pública, bem como de um programa de capacitação científica”, of the *Recovery and Resilience Plan* (Plano de Recuperação e Resiliência – PRR), under the funding contract signed between the *Recovering Portugal Mission Structure* (EMRP) and the Fundação para a Ciência e a Tecnologia I.P. (FCT), as intermediary beneficiary, under the following conditions:

1. **Scientific Area:** Dentistry, Forensic Dentistry
2. **Admission requirements:**
  - a) Bachelor’s degree;
  - b) Have completed the postgraduate course Specialization in Forensic Dental Medicine;
  - c) Have completed an international IOFOS course on “Personal Identification by Dental Methods” with proficiency test;
  - d) Author or co-author of at least 4 articles in the scientific area of forensic dentistry.
3. **Additional optional skills and qualifications:**
  - a) Knowledge in the area of: Forensic and Medico-Legal Age estimation and Python Language;
  - b) Immediate availability.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in PhD in the area of Health Sciences and Technologies.
5. **Work plan:** Participation in the following tasks of the AldentifyAGE project:
  - a) Radiographic collection, selection and management, orthopantomograms, for the project’s image bank. Modelling metadata;
  - b) Radiograph Image Analysis by interval age range and by dental methods for forensic dental age estimation;
  - c) Application of Dental Age Estimation Model in Judicial System;
  - d) Communication and Dissemination of Scientific Outputs.The work plan includes to carry out tasks at the Faculdade de Medicina Dentária da Universidade de Lisboa, Faculdade de Medicina da Universidade de Lisboa and INESC-ID.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16<sup>th</sup> December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12<sup>th</sup> May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt)).
7. **Place of work:** The work will be developed at the CEAUL, Faculdade de Ciências da Universidade de Lisboa under the scientific supervision of Professor Cristiana Palmela Pereira.
8. **Fellowship duration:** This position is initially opened for 6 months due to start in July 2025. The fellowship contract may be potentially renewed for until the end of the project, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.

9. **Monthly allowance:** The fellowship amounts to € 1309,64, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by CV assessment – 50%, demonstrated experience in the area – 50%.  
If necessary, an interview will be held with the 3 (three) best candidates. If an interview is carried out, the weighting will be as follows: CV assessment – 35%, demonstrated experience in the area – 35%, interview – 30%.  
Applicants whose application is scored with a final classification of less than 80 points are not eligible for granting a fellowship.

11. **Selection Committee:** Arlindo Oliveira (President of the jury), Marília Antunes and Lisete Sousa (effective members) and Cátia Vaz and Alexandre Francisco (alternate members).

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 30/06/2025 to 11/07/2025 .

- a. Curriculum vitae;
- b. Certificate of completion of previous degree <sup>Note 1, 2</sup>;
- c. Certificate of postgraduate course “Specialization in Forensic Dental Medicine”;
- d. Certificate of an international IOFOS course on “Personal Identification by Dental Methods”;
- e. At least 4 articles in the scientific area of forensic dentistry, as author or co-author.

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

The personal data will be kept for the period necessary for the execution of the purposes for which they are intended, being ensured the processing and protection in an appropriate and diligent way, the confidentiality and integrity of these data, through appropriate technical and organizational measures.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates' evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID ([fciencias.id@fciencias-id.pt](mailto:fciencias.id@fciencias-id.pt)) within 15 business days after the notification date.

**Note 1:** The documents that prove the entitlement of the academic qualifications and diplomas can be dismissed during the application period and replaced by a declaration on their honour from the applicant ([Minuta PT](#), [Minute EN](#)). Their delivery is mandatory for the fellowship contractualization.

**Note 2:** Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
