Offer Description

At the Faculty of Sciences of the University of Lisbon (Ciências ULisboa), a call is open for the attribution of 1 (one) research grant for Research fellowship financed by Programme Mar2030, under the scope of the Project "CoastNet 2030: Monitoring for the Management of Marine Ecosystems" (MAR-016.9.1-FEAMPA-00010), according to the following conditions:

Work plan:

- Identify the most appropriate satellite and modelling datasets to characterize the Portuguese Exclusive Economic Zone;
- Perform the characterization of the Portuguese Marine Protected Areas (AMPs);
- Participate in opportunity oceanographic campaigns;
- Understand the most important drivers of phytoplankton dynamics in the AMPs;
- Contribute to the development of indicators to assess the good ecological status.

Fellowship duration:

The grant is expected to start on September 2025. The contract, with a duration of 12 (twelve) months, on an exclusive basis, without the possibility of renewal.

Form of presentation of applications:

Applications may be sent by e-mail, to the address candidaturas@ciencias.ulisboa.pt, with the reference " Ref.^a BI-MESTRE-ICNCG-COASTNET-3", under penalty of not being considered for the competition.

Applications must be accompanied, compulsorily and under penalty of exclusion, by the following documents. No document, which must be submitted at the time of application, may be submitted after the deadline for submission:

- Personal data form and declaration of consent for communication of results via e-mail;
- Declaration under oath;
- Proof of enrolment, in the academic year 2024/2025, in a non-academic degree course that is part of the educational project of a higher education institution and developed in association or cooperation with one or more R&D Units or Proof of enrolment, in the academic year 2025/2026, in a non-academic degree course that is part of the educational project of a higher education institution and developed in association or cooperation with one or more R&D Units;
- Detailed and updated Curriculum Vitae;
- Photocopy of the qualification certificate(s) of the academic degree(s) required - MSc degree;
- If the academic degree, required in the present announcement as an admission requirement for the type of scholarship in question, was obtained abroad, you must submit one of the following documents: (See also the NOTES below)

- Document proving the granting, by a Portuguese Institution, of the recognition or equivalence or registration of the academic degree;
- Document proving that you have already applied for the recognition of the degree, which application must be submitted by the deadline for receipt of applications, inclusive.

Notes:

1) The presentation of the proof of obtaining the recognition or equivalence or registration of the academic degree is a mandatory condition for signing the contract;

2) For academic degrees obtained in foreign countries, which have not yet obtained either recognition or equivalence or registration of the degree, it is necessary to recognise it, under the terms provided for in Decree Law no. 66/2018, of 16 August, combined with Ordinance no. 33/2019, of 25 January, as currently amended.

Candidates must fulfil the following mandatory requirements:

- MSc degree in Marine Ecology or similar areas;
- Enrolment, for the academic year 2024/2025, in a study plan that does not grant a degree;
- Experience in long-term data analysis;
- Experience in the analysis of satellite imagery;
- Fluency in Portuguese.

If the academic degree required by the present announcement as an admission requirement for the type of grant in question was obtained abroad, the requirements mentioned in point “Form of presentation of applications” of this announcement regarding the qualification certificates shall be taken into consideration.

Specific Requirements

Preference will be given to candidates with the following requirements:

- Previous participation in oceanographic campaigns;
- Practical knowledge on the analysis of satellite and modelling datasets (temperature, ocean colour, etc.);
- Knowledge on phytoplankton ecology;
- Knowledge on MATLAB/Python programming languages;
- Previous participation in multidisciplinary projects.

Benefits

Monthly allowance and social security:

- The fellowship amount corresponds to € 1309,64 (one thousand three hundred and nine euros and sixty-four cents), according to FCT Regulation for Research Fellowships, published by Regulation no. 950/2019 in the Diário da República, 2nd series, no. 241, of 16th of December, amended by Regulation No. 643/2021, published in the Diário da República, 2nd Series, No. 135, of 14 July, and available in the site of FCT, I.P..

It will be paid monthly by bank transfer;

- The candidate to be hired may exercise his right to social insurance by joining the voluntary social insurance scheme, under the terms of the Statute of the Research Fellowship. The financing entities assume the costs resulting from the contributions provided for this Social Insurance, according to the Statute of the Research Fellowship.

Selection process

Selection criteria:

The applicable selection methods will be curricular evaluation and, eventually, a selection interview.

If the jury chooses to conduct a selection interview, it will be conducted with the three (3) candidates with the best classification in the curricular assessment.

In the event that the selection interview is held, the final evaluation will be obtained considering the following weightings: 50% for the curricular evaluation and 50% for the selection interview.

The selection methods are eliminatory, and candidates who obtain a score of less than 14 in one of the selection methods or stages of the procedure will be excluded, and the next method or stage will not be applied to these candidates.
