

CALL FOR AWARDING GRANTS AND PROJECTS UNDER R & D INSTITUTIONS

Research Fellowship (BI) - Biological/ Biomedical Sciences

One research fellowship (BI-Bolsa de Investigação) is open at the **Fundação da Faculdade de Ciências da Universidade de Lisboa**, at the Membrane Protein Disorders Unit of BioFiG- Center for Biodiversity, Functional & Integrative Genomics, in the scope of the project: **"Characterization of ER-quality control for the F508del-CFTR protein: potential therapeutic targets for cystic fibrosis"** (PTDC/SAU-GMG/122299/2010), financed by national funds by FCT / MCTES (PIDDAC) Portugal, under the program¹)"All Scientific Domains" and under the following conditions:

- Scientific Area: Biochemistry/ Biology & Physiology
- 2. Requirements for admission:

Candidates: should be holders of **an MSc or BSc degree** in Biochemistry/ Biology or related areas. Candidates with strong skills in electrophysiology and cell culture (namely primary cultures of human tissues) will be favoured; they should have an interest in establishing innovative techniques and enjoy working in an international stimulating research environment.

- 3. **Work plan**: Work will focus on biochemical (Westerns, cell-surface biotinylation) and electrophysiological (Ussing chamber) techniques for both the biochemical and functional characterization of CFTR variants from native tissues (from patients) as well as expressed in novel cellular models .The successful candidate will work in an international dynamic and enthusiastic team aiming to elucidate the molecular mechanisms underlying the genetic disease Cystic Fibrosis (CF) and the search for novel therapeutic compounds.
- 4. **Legislation framework**: Portuguese Law Nr. 202/2012, from 27 August (Research Grant Holder Statute); Regulation of Advanced Training and Qualification of Human Resources 2012.
- 5. **Fellowship duration**: This position is initially open for **3 months**, and will begin on **1 January 2013**. The grant contract may be renewed to **more 9 months**, until a **total duration of 12 months**.
- 6. **Place of work**: The work will be developed at the Membrane Protein Disorders Unit of BioFiG- Center for Biodiversity, Functional & Integrative Genomics, at the hosting institution: Faculty of Sciences of the University of Lisboa, C8 bdg, Campo Grande, under the scientific guidance of Professor Margarida Amaral.
 - Monthly allowance: The amount of the scholarship amounts to 980€ (MSc) or 745€ (BSc) according to table values of the scholarships awarded directly by the FCT, ΙP in (http://www.fct.pt/apoios/bolsas/valores). (grants awarded to projects financed by FCT). The Fellow will have a personal accident insurance and, if not covered by any social protection scheme can ensure the right to social security through adherence to voluntary social insurance scheme, pursuant to "Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social". The scholarships will be paid monthly by bank transfer.
- 8. **Selection method**: Candidates will be assessed by the quality of their CV (50%) and experience in the required methodologies (50%) and possibly also an interview.
- 9. **Selection Committee**: Prof. Margarida Amaral (President), FCUL; Prof. Carlos Farinha, FCUL ("Vogal"); Prof. Margarida Carvalho ("Vogal"). (Substitute "Vogaisl".: Prof. Margarida Telhada, FCUL; Prof. Rui Malhó, FCUL)
- 10. Publication/notification of results: The final results of the evaluation will become public, through alphabetically ordered list (selected or rejected) which will be posted at the entrance hall of the Fundação da Faculdade de Ciências da Universidade de Lisboa, located at the Faculdade de Ciências da Universidade de Lisboa, C1 bdg 3rd floor, Campo Grande, 1749-016 Lisboa, and the selected candidate will be notified by e-mail.
- 11. This call for applications is open from 4 December to 17 December 2012.
- 12. **Application:** Applications may be filed via e-mail, attaching the following documents: 1) a motivation letter; 2) CV with list of publications and description of methodological expertise relevant to this application; 3) two references of people well acquainted with the work of the candidate.
