

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### Research Fellowships under Special Regime, 1

#### REF. COMPCON\_1BIRE (tech\_master2)

1 Research Fellowship under Special Regime for master is open at the **FCiências.ID – Associação para a Investigação e o Desenvolvimento de Ciências**, for the project COMPCON: Competition under (niche) construction, GA 725419, financed by the European Commission under the Horizon 2020 Programme (European Research Council, ERC), under the following conditions:

1. **Scientific Area:** Biology.
2. **Requirements for admission:** Master's degree in Biology or related area.
3. **Factors preferred:** Preference will be given to candidates with:
  - a) Experience with laboratory procedures;
  - b) Mastering molecular and/or physiological techniques;
  - c) Knowledge of the spider-mite/plant system.
4. **Work plan:** The applicant will test (a) if mites evolving with an incompatible population increase their discrimination against mates from that population; (b) if the populations that are more reproductively isolated also exhibit lower reproductive or ecological interference and (c) how (a) and (b) affect species coexistence.
5. **Legislation framework:** Statute of the Scientific Research Fellowship, in accordance with Law 40/2004, of 18 August, as amended and republished by Decree-Law No. 202/2012 of 27 August, and as amended by Decree-Law No. 233/2012 of 29 October and by Law No. 12/2013, of January 29, and Decree-Law No. 89/2013 of 9 July; And also by the FCT, I.P. Fellowships Regulation, in force (<http://www.fct.pt/apoios/bolsas/docs/RegulamentoBolsasFCT2015.pdf>) and **FCiências.ID** Fellowship Regulation, as approved on 23<sup>rd</sup> February 2017.
6. **Place of work:** The work will be developed at cE3c: Centre for Ecology, Evolution and Environmental Changes of Faculdade de Ciências da Universidade de Lisboa under the scientific guidance of Sara Magalhães, Flore Zélé and Vitor Sousa.
7. **Fellowship duration:** This position will begin in **February** 2018, or as soon as possible thereafter, and have an initial duration of 6 months. The fellowship contract may be renewed eventually until the end date of the project COMPCON, in accordance with the provisions of the "Regulation of Research Fellowships from the Foundation for Science and Technology, I.P".
8. **Monthly allowance:** The fellowship amount to a monthly allowance of € 1200. The fellowship holder will have a personal accident insurance and, if not covered by any social protection scheme can ensure the right to social security through adherence to the voluntary social insurance scheme, pursuant to Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social. The fellowship will be paid monthly by bank transfer.
9. **Selection method:** Candidates will be assessed by the quality of their CV (40 %), the relevance of their experience (30%) and an interview (30%). Only candidates with ratings above 80% will be interviewed.

All the candidates will be notified of the results by *e-mail*.
  
12. **Deadlines:** This call for applications is open from December 11<sup>th</sup> to 23<sup>rd</sup> 2017.
