One Research Fellowship

One Research Fellowship for Masters is open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the R&D Project KBID, under the following conditions:

1. **Scientific Area:** Bioinformatics
2. **Requirements for admission:** “Licenciatura” in Informatics, Physics, Statistics, Biology or similar (> 15.0 values); Experience in machine learning and modeling; M.Sc. in Bioinformatics, Physics, Statistics, Biology, Biomedicine or similar (> 17.0 values).
3. **Factors preferred:** Relevant experience in scripting (Python, Perl, R, Bash, Java); Relevant experience in mathematical modeling or statistics; Relevant experience in multidisciplinary projects as a team player; Relevant skills for writing scientific publications.
4. **Work plan:** i) knowledge Database development; ii) development of automated modeling systems; iii) validation and testing; iv) collaboration in the implementation of prototype; vi) organization and management associated with the project;
5. **Legislation framework:** Statute of the Scientific Research Fellowship, in accordance with Law 40/2004, of 18 August, as amended and republished by Decree-Law No. 202/2012 of 27 August, and as amended by Decree-Law No. 233/2012 of 29 October and by Law No. 12/2013, of January 29, and Decree-Law No. 89/2013 of 9 July; And also by the FCT, I.P. Fellowships Regulation, in force (<http://www.fct.pt/apoios/bolsas/docs/RegulamentoBolsasFCT2015.pdf>) and **FCiências.ID** Fellowship Regulation, as approved on 23rd February 2017.
6. **Place of work:** The work will be developed at BioISI Institute, Faculdade de Ciências da Universidade de Lisboa. under the scientific guidance of Dr. Ricardo Pedro Moreira Dias
7. **Fellowship duration:** This position is initially opened for 6 months and will begin on March 2018. The fellowship contract may be renewed to more 6 months, or eventually until the end date of the project, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.
8. **Monthly allowance:** The fellowship amounts to 980€, according to table values of the fellowships awarded directly by the FCT, IP. (<http://www.fct.pt/apoios/bolsas/valores>).
The fellowship holder will have a personal accident insurance and, if not covered by any social protection scheme can ensure the right to social security through adherence to the voluntary social insurance scheme, pursuant to Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social.
The fellowship will be paid monthly by bank transfer.
9. **Selection method:** Candidates will be assessed by the quality of their CV (50%) and Previous experience in the area of the project (50%) and possibly also an interview for top3 candidatures (0-100%).
