

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### 1 Special Regime Research Fellowship for a BSc degree

1 (One) Special Regime Research Fellowship for a BSc degree (Licenciatura) is open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, within PLACARD – Platform for Climate Adaptation and Risk Reduction financed by the European Commission under the programme Horizon 2020 Societal Challenges 7 DRS-9a, under the following conditions:

1. **Scientific Area:** Biophysics Engineering, Environmental Engineering, Environmental Sciences and related areas.
2. **Requirements for admission:** The candidate should have a BSc degree (Licenciatura) in Biophysics Engineering, Environmental Engineering, Environmental Sciences and related areas and experience in the following topics:
  - Climate change adaptation or disaster risk reduction (exclusion factor)
  - Organization and facilitation of workshops, conferences and multi-stakeholder planning processes
  - Stakeholder participation methods
  - Excellent English (written and spoken) – Exclusion factor
  - Excellent Portuguese (written and spoken) – Exclusion factor
  - Excellent organization skills and ability to work in a multicultural team.
  - Previous experience working with European projects (exclusion factor).
3. **Factors preferred:** Experience in event organization, good communication skills, good project management capabilities, knowledge in climate change adaptation and/or disaster risk reduction, previous experience working with European projects.
4. **Work plan:** Support the coordination of the European project PLACARD (<http://www.placard-network.eu/>) with the objective of developing an European platform for dialogue, knowledge exchange and collaboration between the Climate Change Adaptation and Disaster Risk Reduction communities, which includes the organization and facilitation of international workshops, team meetings, conferences, project management and planning, contact with stakeholders, writing of reports, scientific and policy briefings. The work plan also includes supporting the organisation of a major European conference, which will take place in 2019. Availability to travel abroad is required.
5. **Legislation framework:** Statute of the Scientific Research Fellowship, in accordance with Law 40/2004, of 18 August, as amended and republished by Decree-Law No. 202/2012 of 27 August, and as amended by Decree-Law No. 233/2012 of 29 October and by Law No. 12/2013, of January 29, and Decree-Law No. 89/2013 of 9 July; And also by the FCT, I.P. Fellowships Regulation, in force (<https://www.fct.pt/apoios/bolsas/docs/RegulamentoBolsasFCT.pdf>) and **FCiências.ID** Fellowship Regulation, as approved on 23<sup>rd</sup> February 2017.
6. **Place of work:** The work will be developed at the Research Group CCIAM (<http://ce3c.ciencias.ulisboa.pt/team/CCIAM>) from the Centre for Ecology, Evolution and Environmental Changes – cE3c of the Faculdade de Ciências da Universidade de Lisboa under the scientific guidance of Dr. Mário Pulquério.
7. **Fellowship duration:** This position is initially opened for 3 months and will begin on the 1<sup>st</sup> of November 2018. The fellowship contract may be renewed until the end date of the project (May 2020), in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.
8. **Monthly allowance:** 1 Special Regime Research Fellowship. The fellowship amounts to €850. The fellowship holder will have a personal accident insurance and, if not covered by any social protection scheme can ensure the right to social security through adherence to the voluntary social insurance scheme, pursuant to Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social. The fellowship will be paid monthly by bank transfer.

9. **Selection method:**

Candidates will be assessed in two stages. The first stage selection will be based on the quality of the CV (80%) (i.e. relevance in relation to the tasks described, experience in research, publications) and Motivation Letter (20%). Successful top 3 first stage candidates will be invited for an interview (100%) (preferably in person, yet also possible via skype). The fellowship will only be granted to the applicants with a minimum score of 4.5 (0-5).

10. **Selection Committee:** The selection will be done by three Jury members: Tiago Capela Lourenço (President), Mário Pulquério (Effective Member), Luís Dias (Effective Member) and Sílvia Carvalho (Effective Member); alternate members of the jury are João Pedro Nunes and Gil Penha-Lopes.

11. **Publication/notification of results:** The results of the evaluation will become public, through ordered list *final grade obtained* which will be posted at the entrance hall of the **FCiências.ID**, located at the Faculdade de Ciências da Universidade de Lisboa, C1 bldg – 3<sup>rd</sup> floor, Campo Grande, 1749-016 Lisboa, and the selected candidate will be notified by *e-mail*.

12. **Deadlines:** This call for applications is open from 19<sup>th</sup> September to 27<sup>th</sup> September 2018.

13. **Application:** Applications may be sent via email to [amantunes@fc.ul.pt](mailto:amantunes@fc.ul.pt), by attaching the following documents: Curriculum vitae, Motivation Letter and Graduate Certificates (sum total cannot be larger than 3 MB). Curriculum vitae and the certificates may be in Portuguese or English, while the motivation letter has to be written in English. Please indicate the following subject PLACARD.

**NOTE:** Please note that Degrees obtained in foreign countries need a Portuguese Recognition certificate and, in some cases, a equivalence certificate issued by a Portuguese high degree institution according to the Decree-Law nr. 341/2007, of Oct 12th, the ministerial order nr. 29/2008, of Jan 10th and the ministerial order nr. 227/2017, of July 25th. The presentation of such certificates is mandatory for contract signature.
