### One Research Fellowship for Doctor

**One Research Fellowship for Doctor** is open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D **Exploratório/IBEB, IF/00787/2014/CP1236/CT0005**, financed by national funds by FCT / MCTES (PIDDAC) under the programme **FCT-Investigador**, under the following conditions:

1. **Scientific Area:** Human cognitive neuroscience or biomedical engineering.
2. **Requirements for admission:** A PhD degree in the human cognitive neuroscience field.
3. **Experience required:** Previous hands-on experience in data acquisition, task paradigm design and statistical analysis for functional MRI and/or eye-tracking&pupillometry and/or skin conductance psychophysiology and/or EEG; and in internationally peer-reviewed scientific writing with first-authorship in previous papers of the human cognitive neuroscience field.
4. **Work plan:** Data acquisition, task paradigm design and statistical analysis in functional MRI, eye-tracking and EEG as part of multimodal pharmacological study.
5. **Legislation framework:** Statute of the Scientific Research Fellowship, in accordance with Law 40/2004, of 18 August, as amended and republished by Decree-Law No. 202/2012 of 27 August, and as amended by Decree-Law No. 233/2012 of 29 October and by Law No. 12/2013, of January 29, and Decree-Law No. 89/2013 of 9 July; And also by the FCT, I.P. Fellowships Regulation, in force (<https://www.fct.pt/apoios/bolsas/docs/RegulamentoBolsasFCT.pdf>) and **FCiências.ID** Fellowship Regulation, as approved on 23<sup>rd</sup> February 2017.
6. **Place of work:** The work will be developed at the Biomedical Neuroscience Lab (Diana Prata's lab) at the IBEB of FCUL (*denomination of the host institution*) under the scientific guidance of Professor Diana Prata.
7. **Fellowship duration:** This position is initially opened for **3 months** and will begin on January of 2019. The fellowship contract may be renewed every 3 or 6 months, up to at least one year, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.
8. **Monthly allowance:** The fellowship amounts to € 1495, non-tax-deductible, according to table values of the fellowships awarded directly by the FCT, IP. (<http://www.fct.pt/apoios/bolsas/valores>), with a possible performance-dependent salary increase.  
The fellowship holder will have a personal accident insurance and, if not covered by any social protection scheme can ensure the right to social security through adherence to the voluntary social insurance scheme, pursuant to Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social.
9. **Selection method:** Candidates will be assessed by the quality of their CV (50%) and interview (50%)
10. **Selection Committee:** Hugo Ferreira, Nuno Matela, Diana Prata, Alexandre Andrade.
11. **Publication/notification of results:** The final results of the evaluation will become public, through ordered list *final grade obtained* which will be posted at the entrance hall of the **FCiências.ID**, located at the Faculdade de Ciências da Universidade de Lisboa, C1 bdg – 3<sup>rd</sup> floor, Campo Grande, 1749-016 Lisboa, and the selected candidate will be notified by *e-mail*.
