

CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

One Science Management Fellowship (BSc) – Cell and Molecular Biology (BGCT)

One Science Management Fellowship for Bsc is open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for BioISI – Biosystems & Integrative Sciences Institute, UID/Multi/04046/2019” financed by national funds by FCT / MCTES (PIDDAC), under the following conditions:

1. **Scientific Area:** Life Sciences
2. **Requirements for admission:** applicants should be holders of a Bsc degree in Life Sciences or related areas. Candidates with skills in management in lab environment would be required. It will be preferred candidates with skills and knowledge in lab work and biochemical techniques. Candidates should enjoy working in an international and stimulating research environment.
3. **Factors preferred:** The jury will especially value the curricular and professional elements that show experience in Laboratory Management.
4. **Work plan:** The successful candidate will be responsible for:
 - The laboratory management and maintenance;
 - Supplier Management;
 - Purchase orders, quotations and invoices, reagents and consumables stock;
 - Databases update;
 - Management of the BioISI Facilities;
 - Shipments, customs and MTA's.
5. **Legislation framework:** Statute of the Scientific Research Fellowship, in accordance with Law 40/2004, of 18 August, as amended and republished by Decree-Law No. 202/2012 of 27 August, and as amended by Decree-Law No. 233/2012 of 29 October and by Law No. 12/2013, of January 29, and Decree-Law No. 89/2013 of 9 July; And also by the FCT, I.P. Fellowships Regulation, in force (<https://www.fct.pt/apoios/bolsas/docs/RegulamentoBolsasFCT.pdf>) and **FCiências.ID** Fellowship Regulation, as approved on 23rd February 2017.
6. **Place of work:** The work will be developed at BioISI, under the scientific guidance of Professor Margarida Amaral
7. **Fellowship duration:** This position is initially opened for 6 months and will begin on February 2019. The fellowship contract may be renewed to more 12 months, or eventually until the end date of the project, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.
8. **Monthly allowance:** The fellowship amounts to € 745-1245, according to professional experience, and according to table values of the fellowships awarded directly by the FCT, IP. (<http://www.fct.pt/apoios/bolsas/valores>). The fellowship holder will have a personal accident insurance and, if not covered by any social protection scheme can ensure the right to social security through adherence to the voluntary social insurance scheme, pursuant to Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social. The fellowship will be paid monthly by bank transfer.

9. **Selection method:** Candidates will be assessed by the quality of their CV (70%). Interviews will be only if necessary (30%), for the 3 best candidates (in case of similar adequacy to the position).
10. **Selection Committee:** The composition of the selection committee is the following: Prof. Margarida Amaral (BioISI Director) as President of the jury; Prof Carlos Farinha and Prof. Margarida Gama-Carvalho as members; Profs. Rui Malhó and Dr. Hugo Botelho as alternate members of the jury.
11. **Publication/notification of results:** The final results of the evaluation will become public, through ordered list *final grade obtained* which will be posted at the entrance hall of the **FCiências.ID**, located at the Faculdade de Ciências da Universidade de Lisboa, C1 bdg – 3rd floor, Campo Grande, 1749-016 Lisboa, and the selected candidate will be notified by *e-mail*.
12. **Deadlines:** This call for applications is open from January 31st to 13th of February 2019.
13. **Application:** Applications may be sent via e-mail to bioisidirector@fc.ul.pt, with the reference “BioISILabManag_[NAME]” , with by attaching the following documents: Curriculum vitae, BSc Certificate, motivation letter and 2 reference letters. Failure in sending any of these elements disqualifies the application. NOTE: Please note that Degrees obtained in foreign countries need a Portuguese Recognition certificate and, in some cases, a equivalence certificate issued by a Portuguese high degree institution according to the Decree-Law nr. 341/2007, of Oct 12th, the ministerial order nr. 29/2008, of Jan 10th, the ministerial order nr. 227/2017, of July 25th and Decree-Law nr. 66/2018, of Aug 16th. The presentation of such certificates is mandatory for contract signature.
