

CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

One Research Fellowship (BI-RE) REF. COMPCON_2BIRE

One Special Regime Research Fellowship(s) (BIRE) for a Master is open at the **FCiências.ID – Associação para Investigação e Desenvolvimento de Ciências**, for the project/R&D institution COMPCON: Competition under (niche) construction, GA 725419, financed by the European Research Council (ERC) under the Horizon 2020 Programme, under the following conditions:

1. **Scientific Area:** Biology
2. **Requirements for admission:** A recognized degree in Biology and experience in handling spider mites
3. **Factors preferred:** Preference will be given to candidates with experience in performing experiments with metal-accumulating plants and in using R
4. **Work plan:** The applicant will work under the supervision of Sara Magalhães.
The tasks assigned to the fellows include:
 - a) Maintaining the populations undergoing experimental evolution in the lab;
 - b) Perform experiments aiming to understand the interaction between spider mites and metal-accumulating plants.
 - c) Perform statistical analyses on the data acquired.
 - d) Assist the other members of the lab in their regular tasks (planting, spider-mite rearings and experiments).
5. **Legislation framework:** Statute of the Scientific Research Fellowship, in accordance with Law 40/2004, of 18 August, as amended and republished by Decree-Law No. 202/2012 of 27 August, and as amended by Decree-Law No. 233/2012 of 29 October and by Law No. 12/2013, of January 29, and Decree-Law No. 89/2013 of 9 July; And also by the FCT, I.P. Fellowships Regulation, in force (<https://www.fct.pt/apoios/bolsas/docs/RegulamentoBolsasFCT.pdf>) and **FCiências.ID** Fellowship Regulation, as approved on 23rd February 2017.
6. **Place of work:** The work will be developed at cE3c: Centre for Ecology, Evolution and Environmental Changes of Faculdade de Ciências da Universidade de Lisboa under the scientific guidance of Professor Sara Magalhães.
7. **Fellowship duration:** This position is initially open for 6 months and will begin in October 2019. The fellowship contract may be renewed until the end date of the project COMPCON, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.
8. **Monthly allowance:** The fellowship amounts to € 1211,88.
The fellowship holder will have a personal accident insurance and, if not covered by any social protection scheme, can ensure the right to social security through adherence to the voluntary social insurance scheme, pursuant to Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social.
The fellowship will be paid monthly by bank transfer.
9. **Selection method:** Candidates will be assessed by the quality of their CV (40 %), the relevance of their experience (40%), and an interview (20%). Only candidates with ratings above 16/20 on the first two factors will be interviewed.

11. **Publication/notification of results:** The final results of the evaluation will become public, through a ranked final grade list, which will be posted at the entrance hall of the **FCiências.ID**, located at the Faculdade de Ciências da Universidade de Lisboa, C1 bdg – 3rd floor, Campo Grande, 1749-016 Lisboa, and the selected candidate will be notified by *e-mail*.
12. **Deadlines:** This call for applications is open from July 1st, 2019 to July 14th, 2019.
