

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

### 1 Research Fellowship (BI) for PhD Student or Master enrolled in a non-degree course

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution NEUROBIOAI - Artificial intelligence-based neuroimaging biomarkers for the diagnosis of neuropsychiatric illnesses, DSAIPA/DS/0065/2018, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme Data Science and Artificial Intelligence in Public Administration - 2018, under the following conditions:

1. **Scientific Area:** Data Science, Artificial intelligence, Statistics, Neuroimaging
2. **Requirements for admission:** 1) MSc in Engineering, Data Science, Statistics or similar fields, with a component in Data Science, Artificial Intelligence, Statistics, or Neuroimaging.
3. **Additional optional skills and qualifications:** Previous experience in statistical data analysis (preferentially psychophysiological data) with machine learning, pattern recognition, use of programming language (preferentially python), and scientific writing in these themes.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in PhD or Post- Graduation non-degree course.
5. **Work plan:** Participation in an academic-clinical-entrepreneurial joint-venture involving: 1) Statistical analysis of magnetic resonance imaging data with a range of pattern recognition and machine learning methods, in a translational (medtech, digital medicine) and innovative study aiming at the development of a software biomarker for the differential, quantitative and objective diagnosis of neurodegenerative illnesses, for clinical use, in a team of engineers and neuroscientists; with Portuguese and UK hospital data. 2) User experience test and clinical usefulness trial of the said software with medical teams in Portuguese hospitals. 3) Work to be done in highly interdisciplinary and international lab: [dpratalab.wordpress.com](http://dpratalab.wordpress.com), and in a collaboration with start-up company NeuroPsyAI, Ltd..
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16<sup>th</sup> December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCIências.ID Fellowship Regulation, as approved on 12<sup>th</sup> May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCIências.ID](https://www.fciencias.id/regulamento-de-bolsas-de-investigacao-cientifica-da-fciencias.id)).
7. **Place of work:** The work will be developed at the Institute of Biophysics and Biomedical Engineering- under the scientific supervision of Professor Diana Prata.
8. **Fellowship duration:** This position is initially opened for 6 months due to start in April 2022. The fellowship contract may be potentially renewed for until end of project, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P.

9. **Monthly allowance:** The fellowship amounts to € 1 144,64 ,according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer

10. **Evaluation and selection process:** Candidates will be assessed by the quality of their CV 50% and Interview (30%) and appraisal from referees (20%).

11. **Selection Committee:** Diana Prata (president of jury), Nuno Matela (1nd member of jury), Joaquim Reis (2nd member of jury) e Hugo Ferreira (substitute)

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 29/03/22 to 11/04/2022 .

15. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCiências.ID ([fciencias.id@fciencias-id.pt](mailto:fciencias.id@fciencias-id.pt)) within 15 business days after the notification date

**Note 1:** The documents that prove the entitlement of the academic qualifications and diplomas, or the proof of registration in the academic degree or diploma requested on the call, can be dismissed during the application period and replaced by a declaration on their honour from the applicant. Their delivery is mandatory for the fellowship contractualization.

**Note 2:** Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
