

CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

1 (one) Post-doctoral Research Fellowship (BIPD)

1 Post Doctoral Research Fellowship(s) (BIPD) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, in the scope own funds for the development of R&D projects, in the area of Physics (initial 10 months of fellowship), and for the project/R&D institution “Centro de Física Teórica e Computacional”, “reference “UIDB/00618/2020 (remaining duration of the fellowship)”, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme Multiannual Funding 2020-2023, under the following conditions:

1. **Scientific Area:** Physics
2. **Requirements for admission:** PhD in Physics or related field, awarded up to one year ago; Post-doctoral research is carried out in a different host entity from the one where the research work that led to the attribution of PhD degree was carried out; The fellowship holder does not exceed, with the signing of the fellowship contract in question, including possible renewals, an accumulated period of three years in this type of fellowship, consecutive or interpolated.
3. **Additional optional skills and qualifications:** Previous experience with simulations of active matter.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas.
5. **Work plan:** To develop simulations to study active matter systems.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](#)).
7. **Place of work:** The work will be developed at the Center for Theoretical and Computational Physics from Faculty of Science, University of Lisbon, under the scientific supervision of Professor Margarida Telo da Gama and Nuno Araújo.
8. **Fellowship duration:** This position is initially opened for 6 months due to start in November 2022. The fellowship contract may be potentially renewed for until the end of the project UIDB/00618/2020, up to a maximum of 24 months.
9. **Monthly allowance:** The fellowship amounts to € 1686, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer

10. **Evaluation and selection process:** Candidates will be assessed by CV (80%) and interview (20%). Applicants whose application is scored with a final classification of less than 70 points are not eligible for granting a fellowship.
11. **Selection Committee:** Prof. Nuno Araújo (president of the jury), Prof. Margarida Telo da Gama (1st member), Dr. Cristóvão Disa (2nd member), Dr. Rodrigo Coelho (1st alternate member), Dr. Manuel Cárdenas-Barrantes (2nd alternate member).
12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.
13. **Deadlines:** This call for applications is open from 24/10/22 to 07/11/2022 .
14. **Application:** Applications should be sent via e-mail to nmaraujo@fc.ul.pt, by attaching the following documents:
- Curriculum vitae - **CV may be provided in PDF or through the [CIÊNCIAVITAE](#) system;**
 - Certificate of completion of previous degree.
15. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date

Note 1: The documents that prove the entitlement of the academic qualifications and diplomas, or the proof of registration in the academic degree or diploma requested on the call, can be dismissed during the application period and replaced by a declaration on their honour from the applicant. Their delivery is mandatory for the fellowship contractualization.

Note 2: Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
