

CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

2 (two) Research Fellowships (BI) for MSc Student

2 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution “ThreatAdapt – Tolerância a faltas e intrusões adaptativa”, FCT-FNR/002/2018”, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme FCT/MCTES (PIDDAC), under the following conditions:

1. **Scientific Area:** Computer Science or related areas.
2. **Requirements for admission:** BSc completed, with successful attendance of curricular units in distributed systems, security, and fault tolerance.
3. **Additional optional skills and qualifications:** Attending curricular units in the areas of distributed systems and blockchains and have interest in making a master thesis on these subjects.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in MSc in Computer Science or related areas.
5. **Work plan:** Implementation and evaluation of improvements in a Byzantine fault-tolerant replication library.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCIências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCIências.ID](#)).
7. **Place of work:** The work will be developed at the LASIGE, Faculty of Sciences of the University of Lisbon under the scientific supervision of Professor Alysson Bessani.
8. **Fellowship duration:** This position is initially opened for 3 months due to start in April 2023.
9. **Monthly allowance:** The fellowship amounts to € 930,98, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.
10. **Evaluation and selection process:** Candidates will be assessed by CV (100%) Applicants whose application is scored with a final classification of less than 60 points are not eligible for granting a fellowship.
11. **Selection Committee:** President: Alysson Bessani; Effective members: Bernardo Ferreira, Nuno Neves; Alternate members: Vinicius Cogo, António Casimiro.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.
13. **Deadlines:** This call for applications is open from 07/03/2023 to 20/03/2023 .
14. **Application:** Applications should be sent via e-mail to lasige-candidaturas@listas.di.ciencias.ulisboa.pt, indicating - otherwise they will not be considered eligible - in the "Subject": Ref. 668.7 - 2 BI EM ThreatAdapt, by attaching the following documents:
- Curriculum vitae, mandatory with the indication of the degrees obtained and/or to be attended, curricular units, respective marks and ECTS - **CV may be provided in PDF or through the CIÊNCIAVITAE system;**
 - Certificate of completion of previous degree;
 - and other documents considered relevant.
15. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date

Note 1: The documents that prove the entitlement of the academic qualifications and diplomas, or the proof of registration in the academic degree or diploma requested on the call, can be dismissed during the application period and replaced by a declaration on their honour from the applicant. Their delivery is mandatory for the fellowship contractualization.

Note 2: Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the [Decree-Law nr. 66/2018](#) (August 16) and the [Ministerial Order nr. 33/2019](#) (January 25).
