1 Research Fellowship under Special Regime (BI-RE) for a PhD Student

1 Research Fellowship(s) under Special Regime (BI-RE) is (are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the Project “coralINT: Integrated Niche Theory: linking environmental, compositional and functional change on coral reefs”, HORIZON-ERC-COG-101044975, financed by the European Union within the scope of Horizon Europe - Community Framework Program for Research & Innovation, through Grant Agreement no. 101044975, under the following conditions:

1. **Scientific Area:** Marine Science
2. **Requirements for admission:** Bachelor’s Degree in Biology, Environmental Sciences, Oceanography, Mathematics, Physics, Engineering, or Computer Science.
3. **Additional optional skills and qualifications:** Familiarity with reef ecology, photogrammetry software and coding (e.g. R, python). Proficiency in English.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas. Enrolment in a Doctoral Programme.
5. **Work plan:** The student will lead their research within the ERC CoralINT work plan, which broadly aims at investigating the relationships between compositional, functional and environmental change, using coral reefs as study system. The student will collect and get access to multi-scale coral reef data and will be asked to identify research questions and analysis to tackle specific aspects of interest within the main aims of the CoralINT project. It is expected from the student to lead experimental and/or theoretical work, participate to fieldtrips, analyze data, write papers and disseminate results.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](#)).
7. **Place of work:** The work will be developed at MARE at the Faculty of Sciences of the University of Lisbon under the scientific supervision of Professor Maria Dornelas.
8. **Fellowship duration:** This position is initially opened for 12 months and due to start in October 2023. The fellowship contract may be potentially renewed for 36 months, in accordance with the provisions of Regulation of Research Fellowships from the Foundation for Science and Technology, I.P and FCiências.ID Fellowship Regulation.
9. **Monthly allowance:** The fellowship amounts to € 1500, according to [table values](#) of the FCiências.ID Fellowship Regulation. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer. Additionally, it may be paid a tuition fees support grant (SAP) to support the costs with the annual tuition fees.

10. **Evaluation and selection process:** Candidates will be assessed by CV (60%), motivation letter (40%). If necessary, an interview will be held with the 5 (five) best candidates. In case of interview, the final evaluation will be as follows: 40% for the curriculum evaluation, 30% for the motivation letter and 30% for the selection interview classification.

Applicants whose application is scored with a final classification of less than 80 points are not eligible for granting a fellowship.

11. **Selection Committee:** Maria Dornelas as President of the jury, Viviana Brambilla and James Cant as effective members and Garrett Fundakowski and Cher Chow alternate members.

12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.

13. **Deadlines:** This call for applications is open from 16/06/2023 to 06/07/2023 .

14. **Application:** Applications should be sent via e-mail to madornelas@fc.ul.pt, by attaching the following documents:

- a. Curriculum vitae;
- b. Certificate of completion of previous degree;
- c. Motivation letter.

15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

The personal data will be kept for the period necessary for the execution of the purposes for which they are intended, being ensured the processing and protection in an appropriate and diligent way, the confidentiality and integrity of these data, through appropriate technical and organizational measures.

Personal data may be transmitted to third parties, namely the entity funding the research project, solely for the purposes specifically established. In this sense, whenever the transfer of personal data to countries outside the European Union and/or international organizations is necessary, compliance with the applicable legal provisions is ensured.

You have the right to request access, rectification, elimination, limitation of processing, the right to object and also data portability (if technically feasible), through the e-mail address: dpo@fciencias-id.pt. 16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date

Note 1: The documents that prove the entitlement of the academic qualifications and diplomas, or the proof of registration in the academic degree or diploma requested on the call, can be dismissed during the application period and replaced by a declaration on their honour from the applicant. Their delivery is mandatory for the fellowship contractualization.
