

CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

1 (one) Post-Doctoral Research Fellowship (BIPD)

1 Post Doctoral Research Fellowship(s) (BIPD) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution “Geometry of Non-generic isomonodromic deformations: exploratory analysis and applications (GENIDE)”, “2022.03702.PTDC”, funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme Programme All Scientific Domains (PTDC) -2022, under the following conditions:

1. **Scientific Area:** Geometry and Mathematical Physics
2. **Requirements for admission:**
 - a) Ph.D. in Mathematics;
 - b) To hold a PhD degree obtained in the three years prior to the date of submission of the application for the fellowship;
 - c) Post-doctoral research is carried out in a different host entity from the one where the research work that led to the attribution of PhD degree was carried out.
3. **Additional optional skills and qualifications:** Not applicable.
4. **Contracting requirements:** Presentation of the academic qualifications and/or diplomas.
5. **Work plan:** The work is aimed to develop research in the area of geometry and asymptotic analysis of ordinary differential equations in complex domains and their applications, working under the supervision of Giordano Cotti, within the project 2022.03702.PTDC.
6. **Legislation framework:** Research Fellowship Holder Statute, in accordance with Law 40/2004, of 18 August, in its current version and the FCT Regulation for Research Studentships and Fellowships, in its current version (Reg. 950/2019 published in DR on 16th December: <https://dre.pt/application/file/a/127230968>, or at the FCT website: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and FCiências.ID Fellowship Regulation, as approved on 12th May 2020 (available at [Regulamento de Bolsas de Investigação Científica da FCiências.ID](https://www.fciencias.id/regulamento-de-bolsas-de-investigacao-cientifica-da-fciencias.id)).
7. **Place of work:** The work will be developed at the Grupo de Física-Matemática da Universidade de Lisboa (GFMUL) of the Faculty of Sciences of the University of Lisbon, Campo Grande under the scientific supervision of Professor Giordano Cotti.
8. **Fellowship duration:** This position is initially opened for 6 months due to start in September 2023. The fellowship contract may be potentially renewed for 6 months.
9. **Monthly allowance:** The fellowship amounts to € 1741,00, according to [table values](#) of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.

10. **Evaluation and selection process:** Candidates will be assessed by a) the quality of their CV (40%); b) Research project (30%); c) Motivation letter, indicating the proximity of their research interests with the subject developed at GFMUL (20%); d) recommendation letters (10%).
The interview is optional for those candidates who exceed the threshold of 80/100 points. In case of interview, the sum of the evaluations obtained in the evaluation criteria a), b), c) and d) will correspond to 80% of the final classification and the interview to 20%.
Applicants whose application is scored with a final classification of less than 90 points are not eligible for granting a fellowship.
11. **Selection Committee:** Giordano Cotti (President of the jury), Davide Masoero (member), Jean-Claude Zambrini (member), Ana Bela Cruzeiro (alternate member), Giulio Ruzza (alternate member).
12. **Publication/notification of results:** All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.
13. **Deadlines:** This call for applications is open from 01/06/2023 to 30/06/2023 .
14. **Application:** Applications should be sent via e-mail to gcotti@fc.ul.pt, by attaching the following documents:
- Curriculum vitae;
 - Certificate of completion of previous degree;
 - Research project;
 - Motivation letter;
 - 2 recommendation letters.
15. **Processing of personal data:** FCIências.ID – Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCIências.ID (fciencias.id@fciencias-id.pt) within 15 business days after the notification date
