Selection criteria:

1. The best average for application to higher education.

Holders of other Higher Education Courses

1. Can apply those who have a bachelor's degree, a master's degree and a PhD degree from another institution/course pair of Portuguese Higher Education.
2. Students of Portuguese nationality, from a Member State of the European Union nationality or Students who are not covered by the International Student Statute, who are holders of equivalence/recognition of a higher academic degree obtained abroad.

Needed Documents to upload:

- Identity Document - optional;
- Tax File Number (TFN) - optional;
- Certificate of conclusion of the degree with mention of the final classification obtained, date of conclusion and discriminated grades; (Not applicable to FCUL alumni)

Selection criteria:

1. The best average from the qualifications they hold;
2. In case of a tie, preference will be given to applicants that finished the course in a shorter period;
3. In case of a tie, preference will be given to former students of FCUL.
