**APPLICATION FOR 2024/2025 ACADEMIC YEAR**

**Application Conditions:**

In order to apply for a Master Degree, the international student must have:

- 1st Cycle “Licenciatura” degree concluded, or **legal equivalence**;
- Holder of a foreign academic Degree conferred after concluding a 1st Cycle Degree of studies, organized according to the Bologna Process, by a Member State adhering to this process;
- Holder of a foreign academic Degree that is recognized by the Scientific Council of the higher education institution for which they are applying for (this recognition must meet the purposes of a 1st Cycle Degree);
- Holder of an academic, scientific or professional curriculum that is recognized as attesting the capacity to accomplish this cycle of studies by the Scientific Council of the higher education institution for which they are applying for.

Consider as **legal equivalence** the degrees recognized under [Decreto-Lei nº 66/2018](#) of 16 August, as well as grades that have been recognized or considered equivalent under previous legislation (Decreto-Lei nº. 283/83, of June 21, and Decreto-Lei nº. 341/2007, of October 12).

**The validity of the referred degrees must be confirmed by the competent authority of the state from which the documents are originated.** The Final Certificates/Diplomas must be certified by the Portuguese consular services or be presented with the Apostille (Hague Convention) by the competent authority of the state from which the documents are originated, and whenever they are not issued in Portuguese, English, French or Spanish, they must be translated into one of these languages (validated by the consular or embassy services).

**Admission Conditions:**

In order to apply for a 2<sup>nd</sup> Cycle, international students must demonstrate the knowledge and expertise required by the course for which they are applying for and a proof of language skills appropriate to the frequency of the course.

**Application period:**

**2<sup>nd</sup> PERIOD:** 24<sup>th</sup> JUNE to 19<sup>th</sup> JULY 2024.

### **Documents required:**

- *Curriculum Vitae*;
- Diploma<sup>1</sup> or Legal Equivalence;
- Grades Certificate<sup>1</sup>;
- Grades Programmes - syllabus and workload of the subjects stamped and signed by the institution of higher education (only for applicants whose degree or legal equivalent is from a foreign institution outside of European Union countries);
- Sworn Statement (declaration of honor and signed by the applicant, stating that the candidate has not the Portuguese nationality and is not included in any of the special conditions which confirm the International Student Status, according to the International Student Statute, approved by legislation (artigo 3.º do [Decreto-Lei n.º 36/2014](#) de 10 de março, modified by [Decreto-Lei nº 62/2018](#) de 06 de Agosto 2018) - [Draft](#);
- Motivation letter;
- Declaration, stating the acknowledgement of the degree and the Higher Education Institution - issued by DGES-Direção Geral de Ensino Superior in Portugal (only apply to candidates whose Bachelor's degree or equivalent is from a foreign institution outside of European Union countries);
- Passport or foreign Identity Card (optional);
- Proof of knowledge of English or Portuguese language (if applicable);

<sup>1</sup>**Attention:** The Certificates/Diploma must be certified by the Portuguese consular service or be presented with the Apostille (Hague Convention) by the competent authority of the state from which the documents are originated, and whenever they are not issued in Portuguese, English, French or Spanish, they must be translated into one of these languages (validated by the consular or embassy services).

The original documents of the Diploma/certificates must be presented in the registration/enrollment as well the identification card or passport.

**Registration and Tuition Fees:**

Application fee: 60€.

Deposit: 500€\*

Registration fee: 40€.

**Annual Tuition Fee:** (can be pay through installments): 7.000€

\*As required in *Despacho D/20/2024*, after being informed of their admission, candidates are obliged to pay the deposit provided for in the Table of Fees of the *Faculdade de Ciências* of the *Universidade de Lisboa* in force. The amount paid as a deposit will revert to the payments due, following admission, for enrolment/registration on the respective course.

**Deadlines for payment of the deposit:**

The deposit fee must be paid within a continuous period of no more than 5 days following the publicising of the results of each application phase.

Failure to pay the deposit within the established period means that candidates will not be able to enrol and, consequently, will lose their place on the course to which they have been admitted.
