2. Detailed requirements and additional information

2.1. Recommended language skills

The sending institution, following agreement with our institution, is responsible for providing support to its nominated candidates so that they can have the recommended language skills at the start of the study or teaching period:

- 1. The student must apply for the Free Spanish Language Course by checking the corresponding box in the Application Form.
- 2. Students who have a pplied for the cours e, must take a <u>compulsory</u> level test that will be he ld at U CM the first week of September (for 1st semester/Full year students) and first week February for 2nd semester students. The exact date and place will be provided well in a dvance to each student by e-mail. Ple ase, bear this course in mind for accommod ation arrangements.
- 3. The intensive language course will be developed along the month of September (for first semester or full year students) and February (for secon d semester students). This course is previous to the beginning of the Year/Semester. As mentioned above, this free course will be offered for levels under B-2 (B-2 included).

Students whose level is C-1 or C-2 are not eligible to attend the FREE Spanish courses. However,

2.2. Additional requirements

- **2.2.1.** The number of students you will send may by no means exceed the number of students mentioned in this agreement. More specifically, we do not accept the mechanism by which shorter periods of stay allow for the sending of more students, i.e. on an exchange of 1 student for 10 months, you may not freely send 2 students for 5 months, not even if their stay covers different semesters. Please take this into consideration when organising your students selection

Autumn term	The students who are nominated for the whole academic year or the first semester will have to apply starting March 30th and ends June 15th . Except, for the students applying to the Faculty of Medicine the deadline is May 30st
Spring term	For those st udents that are nominated to come for the second semester then they will have to apply starting October 15th and will end November 30th .
	However, the students a pplying to the F aculty of Medicine in the seco nd semester will have to contact directly with the Erasmus Office of Medicine to confirm the deadline

2.3.2. Decision Response

We will send our decision within 4 weeks since the end of deadline.

2.3.3. Transcripts of Records

A Transcript of Records will be issued no later than 6 weeks after the assessment period has finished at our institution.

2.3.4. Termination of Agreement

The above parties agree on the present agreement and the activities listed below replace any other previous agreement. For each academic year, both parties will have the opportunity to review the exchanges. After notifying the partner institution, and if agreeded by that institution, amendments of the mobility figures can be made annually. One of the parties may also decide to can cell the a greement, after having notified the partner institution not later than 1 year prior to the start of respective academic year. The ECTS Student Application includes: Student Registration filled ON LINE once printed Academic Recognition / Learning Agreement (please check with the UCM area coordinator for details on the Curricula) Academic Transcript These documents, with the original signatures and stamps from the home university have to be sent to us, by post. Its reception in our Erasmus Central Office closes the whole inscription process. Students must choose their courses among those offered by the Faculty in our University (exceptionally, they would be allowed to take a maximum of two annual or two semester courses each semester in a different area) Due to the overpopulation of our University, we are not able to split semesters, neither to accept extra students. We can only accept applications from students who have been nominated by their home university with which we have a formal bilateral agreement. We regret we are unable to accept Erasmus free movers.
